HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB26-1038 be amended as follows:

- 1 Amend printed bill, page 11, line 9, strike "COMPETITIVENESS." and
- 2 substitute "COMPETITIVENESS AND MAY ALSO ADOPT OTHER MEASURES OF
- 3 DISTRICT COMPETITIVENESS."
- 4 Page 11, line 10, strike "BEFORE ADOPTING A COMPOSITE FORMULA," and
- 5 substitute "AT LEAST SEVENTY-TWO HOURS BEFORE ADOPTING A
- 6 COMPOSITE FORMULA OR OTHER MEASURE OF COMPETITIVENESS,".
- 7 Page 11, line 11, after "FORMULA" insert "OR OTHER MEASURE OF
- 8 COMPETITIVENESS".
- 9 Page 11, line 14, after "FORMULA" insert "OR OTHER MEASURE OF
- 10 COMPETITIVENESS".
- 11 Page 12, strike lines 6 through 22 and substitute:
 - 12 "(II) "COMPOSITE FORMULA" MEANS A FORMULA THAT AVERAGES
 - 13 THE MARGIN OF VICTORY ACROSS THE MOST REPRESENTATIVE
 - 14 COMBINATION OF NATIONAL, STATEWIDE, OR LOCAL ELECTIONS, AS
 - 15 DETERMINED BY THE COMMISSION, TO DETERMINE A DISTRICT'S
 - 16 COMPETITIVENESS MEASURE EXPRESSED AS A PERCENTAGE.
 - 17 (III) "HIGHLY COMPETITIVE DISTRICT" MEANS A DISTRICT WITH A
 - 18 COMPETITIVENESS MEASURE GREATER THAN OR EQUAL TO NEGATIVE FIVE
 - 19 PERCENT AND LESS THAN OR EQUAL TO FIVE PERCENT.
 - 20 (IV) "MARGIN OF VICTORY" MEANS, FOR AN ELECTION, THE
 - 21 DIFFERENCE BETWEEN THE PERCENTAGE OF VOTES CAST FOR THE
 - 22 CANDIDATE OF THE STATE'S LARGEST POLITICAL PARTY AND THE
 - 23 PERCENTAGE OF VOTES CAST FOR THE CANDIDATE OF THE STATE'S SECOND
 - 24 LARGEST POLITICAL PARTY.
 - 25 (V) "MODERATELY COMPETITIVE DISTRICT" MEANS A DISTRICT
 - 26 WITH A COMPETITIVENESS MEASURE EITHER GREATER THAN FIVE PERCENT
 - 27 AND LESS THAN OR EQUAL TO TEN PERCENT, OR LESS THAN NEGATIVE FIVE
 - 28 PERCENT AND GREATER THAN OR EQUAL TO NEGATIVE TEN PERCENT."
