13 A POWER OUTPUT OF NOT MORE THAN THREE HUNDRED NINETY-ONE
14 WATTS IN THE STATE AND IS NOT UL LABELED AND LISTED. "

19 GENERATION DEVICE;
20 (b) A COVENANT OR RESTRICTION THAT EXPLICITLY OR
21 INDIRECTLY PROHIBITS OR UNREASONABLY RESTRICTS THE INSTALLATION,
22 USE, OR OPERATION OF A PORTABLE-SCALE SOLAR GENERATION DEVICE IS
23 UNENFORCEABLE AND VOID AS A MATTER OF PUBLIC POLICY; AND
24 (c) A PORTABLE-SCALE SOLAR GENERATION DEVICE IS CONSIDERED
25 AN ENERGY EFFICIENCY MEASURE FOR THE PURPOSES OF SECTION
26 38-33.3-106.7; EXCEPT THAT, NOTWITHSTANDING SECTION 38-33.3-106.7
27 (3)(d), A REAL PROPERTY OWNER MAY INSTALL, USE, OR OPERATE A
28 DEVICE ON REAL PROPERTY THAT IS A LIMITED COMMON ELEMENT OF A
29 COMMON INTEREST COMMUNITY.
30 (8) A PROVIDER OF RETAIL ELECTRIC SERVICE OR WHOLESALE
31 ENERGY IS NOT LIABLE FOR ANY DAMAGE OR INJURY CAUSED BY A
32 PORTABLE-SCALE SOLAR GENERATION DEVICE."

15 PRODUCTION METER AS A CONDITION OF INTERCONNECTION FOR A
16 CUSTOMER-SITED DISTRIBUTED ENERGY RESOURCE, EXCEPT IF THE
17 CUSTOMER ELECTS TO PARTICIPATE IN A PRODUCTION-BASED INCENTIVE
18 PROGRAM."

22 **38-33.3-106.7. Unreasonable restrictions on energy efficiency**
23 **measures - definitions.**

24 (1) (b) As used in this section, "energy efficiency measure" means
25 a device or structure that reduces the amount of energy derived from
26 fossil fuels that is consumed by a residence or business located on the real
27 property. "Energy efficiency measure" is further limited to include only
28 the following types of devices or structures:

29 (V) A retractable clothesline; and

30 (VI) A heat pump system, as defined in section 39-26-732 (2)(c);

31 AND

32 (VII) ON AND AFTER JANUARY 1, 2027, A PORTABLE-SCALE SOLAR
33 GENERATION DEVICE, AS DEFINED IN SECTION 40-2-140 (1)(e)."
