

HB26-1037 be amended as follows:

- 1 Amend printed bill, page 3, after line 27 insert:
2 "(a) "CONSUMER PERSONAL DATA" MEANS INFORMATION
3 COLLECTED FROM OR GENERATED BY A SPECIFIC PERSON AS PART OF A
4 CONSUMER TRANSACTION OR THE USE OF A CONSUMER PRODUCT OR
5 SERVICE, WHETHER THE INFORMATION WAS COLLECTED BY THE ORIGINAL
6 THIRD PARTY OR OBTAINED BY A DIFFERENT THIRD PARTY, THAT IS
7 CONNECTED OR REASONABLY CONNECTED TO THE SPECIFIC PERSON OR THE
8 SPECIFIC PERSON'S ELECTRONIC DEVICE. CONSUMER PERSONAL DATA
9 INCLUDES, BUT IS NOT LIMITED TO, A PERSON'S:
10 (I) BILLING INFORMATION OR ADDRESS;
11 (II) SOCIAL SECURITY NUMBER;
12 (III) HOME ADDRESS;
13 (IV) DEMOGRAPHIC DATA;
14 (V) WEB BROWSING OR SEARCH HISTORY;
15 (VI) APPLICATION USAGE HISTORY;
16 (VII) PRECISE GEOLOCATION DATA, AS DEFINED IN SECTION
17 6-1-1303;
18 (VIII) FINANCIAL INFORMATION;
19 (IX) HEALTH INFORMATION;
20 (X) BIOMETRIC IDENTIFIER, AS DEFINED IN SECTION 6-1-1303;
21 (XI) BIOLOGICAL DATA, AS DEFINED IN SECTION 6-1-1303;
22 (XII) CHARACTERISTICS OF PROTECTED CLASSIFICATIONS UNDER
23 STATE OR FEDERAL LAW;
24 (XIII) DEVICE IDENTIFIER, INCLUDING A MEDIA ACCESS CONTROL
25 ADDRESS, INTERNATIONAL MOBILE EQUIPMENT IDENTIFIER, OR INTERNET
26 PROTOCOL ADDRESS;
27 (XIV) COMMUNICATIONS CONTENT; AND
28 (XV) PROFILES OR INFERENCES ABOUT AN INDIVIDUAL BASED ON
29 DATA POINTS COLLECTED OR ACQUIRED FROM THIRD PARTIES."
- 30 Reletter succeeding paragraphs accordingly.
- 31 Page 4, line 16, strike "LAW." and substitute "LAW ON BEHALF OF THE
32 STATE OR A LOCAL GOVERNMENT."
- 33 Page 5, strike lines 23 through 25 and substitute "AVAILABLE TO THE
34 GENERAL PUBLIC THROUGH CHANNELS THAT ARE DISTRIBUTED BROADLY
35 AND WITH REGULAR DISSEMINATION, SUCH AS A SOCIAL MEDIA PROFILE
36 THAT DOES NOT LIMIT WHO CAN ACCESS THE CONTENT, INCLUDING IF THE
37 USER IS REQUIRED TO HAVE A SUBSCRIPTION OR ACCOUNT TO ACCESS THE
38 CONTENT, AND THAT ARE NOT TARGETED, PRIVATE, RESTRICTED, OR NICHE
39 COMMUNICATIONS."
- 40 Page 6, line 4, strike "REQUEST, OBTAIN," and substitute "OBTAIN".
- 41 Before "PERSONAL" insert "CONSUMER" on: **Page 5**, line 21; **Page 6**, lines
42 2, 5, 11, 13, 17, and 25; **Page 7**, lines 5, 10, 12, 14, 15, and 19; and **Page**
43 **8**, line 6.
