

HB26-1037 be amended as follows:

1 Amend printed bill, page 4, strike lines 17 through 27.

2 Page 5, strike lines 1 through 18.

3 Reletter succeeding paragraphs accordingly.

4 Page 7, strike lines 23 through 26 and substitute:

5 "(4) IT IS NOT A VIOLATION OF SUBSECTION (2) OF THIS SECTION IF
6 A PERSON MAKES THEIR CONSUMER PERSONAL DATA PUBLICLY
7 AVAILABLE, REGARDLESS OF THE SOURCE FROM WHICH A LAW
8 ENFORCEMENT ENTITY OBTAINS THE PERSONAL DATA."

9 Page 7, line 27, strike "INJURY," and substitute "INJURY TO THE PERSON
10 THE CONSUMER PERSONAL DATA PERTAINS TO,".

11 Page 8, line 1, after "ACTION" insert "AGAINST THE GOVERNMENT
12 ENTITY".

13 Page 8, line 4, after "A" insert "PREVAILING".

14 Page 8, after line 19 insert:

15 "(6) PURSUANT TO SECTION 6-1-105 (1)(qqqq), IT IS A DECEPTIVE
16 TRADE PRACTICE TO, IN THE COURSE OF A PERSON'S BUSINESS, VOCATION,
17 OR OCCUPATION, EXCHANGE CONSUMER PERSONAL DATA THAT DOES NOT
18 QUALIFY AS AN EXCEPTION PURSUANT TO THIS SECTION WITH A LAW
19 ENFORCEMENT OR GOVERNMENT ENTITY FOR ANYTHING OF VALUE."

20 Page 8, after line 27 add:

21 "**SECTION 5.** In Colorado Revised Statutes, 6-1-105, **amend**
22 (1)(oooo) and (1)(pppp); and **add** (1)(qqqq) as follows:

23 **6-1-105. Unfair or deceptive trade practices - definitions.**

24 (1) A person engages in a deceptive trade practice when, in the
25 course of the person's business, vocation, or occupation, the person:

26 (oooo) Violates article 29 of this title 6; ~~or~~

27 (pppp) Violates part 18 of this article 1; OR

28 (qqqq) EXCHANGES WITH A LAW ENFORCEMENT OR GOVERNMENT
29 ENTITY FOR ANYTHING OF VALUE CONSUMER PERSONAL DATA, AS DEFINED
30 IN SECTION 16-3-303.3, THAT DOES NOT QUALIFY AS AN EXCEPTION LISTED
31 IN SECTION 16-3-303.3."

32 Renumber succeeding section accordingly.
