SB26-078 be amended as follows:

1 Amend printed bill, page 4, strike lines 11 through 15 and substitute
2 "campuses; AND
3 (b) The institution whose campus is established under and
4 specified in section 23-20-101 (1)(b); ~~but limited to~~ EXCEPT THAT, FOR
5 BUILDINGS LOCATED WITHIN THE GROUNDS OF THE AURARIA HIGHER
6 EDUCATION CENTER CREATED IN PART 70 OF THIS ARTICLE 23, "QUALIFIED
7 STATE INSTITUTION OF HIGHER EDUCATION" MEANS ONLY THOSE
8 BUILDINGS THAT ARE CONSTRUCTED OR WHOLLY RENOVATED FROM

16 (b) The institution whose campus is established under and
17 specified in section 23-20-101 (1)(b); ~~but limited to~~ EXCEPT THAT, FOR
18 BUILDINGS LOCATED WITHIN THE GROUNDS OF THE AURARIA HIGHER
19 EDUCATION CENTER CREATED IN PART 70 OF THIS ARTICLE 23, "QUALIFIED
20 STATE INSTITUTION OF HIGHER EDUCATION" MEANS ONLY THOSE
21 BUILDINGS THAT ARE CONSTRUCTED OR WHOLLY RENOVATED FROM
22 MONEY HELD BY THE UNIVERSITY OF COLORADO AT DENVER AND THAT
23 ARE CURRENTLY OWNED, OPERATED, AND MAINTAINED BY THE
24 UNIVERSITY OF COLORADO AT DENVER, INCLUDING the buildings located
25 in Denver at ~~1380 Lawrence street, 1250 Fourteenth street, and 1475~~
26 ~~Lawrence street;~~ and 1191 LARIMER STREET, 1201 LARIMER STREET, AND
