HB26-1061 be amended as follows:

- 1 Amend printed bill, page 6, after line 27 insert:
2 "SECTION 3. In Colorado Revised Statutes, add 24-32-705.9 as
3 follows:
4 **24-32-705.9. Competitive financial assistance applications -**
5 **community integration housing scoring preference - rules -**
6 **definitions.**
7 (1) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
8 PROVIDES:
9 (a) "AUTHORITY" MEANS THE COLORADO HOUSING AND FINANCE
10 AUTHORITY CREATED IN SECTION 29-4-704.
11 (b) "COMMUNITY INTEGRATION HOUSING" MEANS HOUSING THAT
12 MEETS THE REQUIREMENTS SET FORTH IN SECTION 39-22-572 (4)(b).
13 (c) "DISABILITY" HAS THE MEANING SET FORTH IN SECTION
14 24-34-301 (7).
15 (d) "HCBS WAIVER SERVICES" MEANS HOME- AND
16 COMMUNITY-BASED SERVICES FOR PERSONS WITH DISABILITIES ALLOWED
17 TO BE FURNISHED IN NONINSTITUTIONAL, COMMUNITY SETTINGS AS AN
18 ALTERNATIVE TO INSTITUTIONAL CARE PURSUANT TO 42 U.S.C. SEC.
19 1396n (c).
20 (2) THIS SECTION APPLIES TO ANY COMPETITIVE APPLICATION
21 PROCESS FOR FINANCIAL ASSISTANCE, INCLUDING GRANTS, LOANS, GAP
22 FINANCING, RENTAL ASSISTANCE, OR OTHER HOUSING RESOURCES
23 ADMINISTERED BY THE DIVISION.
24 (3) IN ADOPTING GUIDELINES, NOTICES OF FUNDING AVAILABILITY,
25 OR SCORING CRITERIA FOR ANY PROGRAM DESCRIBED IN SUBSECTION (1)
26 OF THIS SECTION, THE DIVISION SHALL, IN CONSULTATION WITH THE
27 AUTHORITY AND THE DEPARTMENT OF HEALTH CARE POLICY AND
28 FINANCING, INCLUDE SCORING PREFERENCES TO PROMOTE COMMUNITY
29 INTEGRATION HOUSING."
- 30 Page 1, line 102, strike "TEN PERCENT OF".
- 31 Page 1, line 103, strike "SET ASIDE" and substitute "AWARDED".
- 32 Page 1, lines 106 and 107, strike "INTELLECTUAL AND DEVELOPMENTAL
33 DISABILITIES." and substitute "DISABILITIES, AND REQUIRING THE
34 DIVISION OF HOUSING TO IMPLEMENT A COMMUNITY INTEGRATION
35 HOUSING SCORING PREFERENCE FOR COMPETITIVE FINANCIAL
36 ASSISTANCE APPLICATIONS."
