

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB23-1020 be amended as follows:

- 1 Amend the Business Affairs & Labor Committee Report, dated February
- 2 23, 2023, page 1, line 4, strike "(58), and (65);" and substitute "and (58);".
- 3 Page 2, strike lines 5 through 7 and substitute "TO DELIVER AND SELL
- 4 RETAIL MARIJUANA AND RETAIL MARIJUANA PRODUCTS TO CONSUMERS AT
- 5 THE CONSUMER'S PRIVATE RESIDENCE PURSUANT TO THIS ARTICLE 10;
- 6 RULES PROMULGATED PURSUANT TO THIS ARTICLE 10; AND THE
- 7 PROVISIONS OF AN ENACTED, INITIATED, OR REFERRED ORDINANCE OR
- 8 RESOLUTION OF THE LOCAL JURISDICTION IN WHICH THE LICENSEE
- 9 OPERATES.".
- 10 Page 2, strike lines 14 through 23.
- 11 Page 3, strike lines 2 through 14, and substitute:
 - 12 "(kk) INDEPENDENT DELIVERY LICENSES, INCLUDING:
 - 13 (I) PROCEDURES FOR A SOCIAL EQUITY LICENSEE WHO HOLDS A
 - 14 RETAIL TRANSPORTER LICENSE AND A RETAIL MARIJUANA DELIVERY
 - 15 PERMIT TO CONVERT TO AN INDEPENDENT DELIVERY LICENSE PRIOR TO
 - 16 JANUARY 2, 2024;
 - 17 (II) PROCEDURES FOR A SOCIAL EQUITY LICENSEE TO APPLY FOR AN
 - 18 INDEPENDENT DELIVERY LICENSE;
 - 19 (III) REQUIREMENTS AND CONDITIONS UNDER WHICH AN
 - 20 INDEPENDENT DELIVERY LICENSEE MAY PURCHASE, STORE, AND CONDUCT
 - 21 SALES OF RETAIL MARIJUANA AND RETAIL MARIJUANA PRODUCTS;
 - 22 (IV) REQUIREMENTS AND CONDITIONS UNDER WHICH AN
 - 23 INDEPENDENT DELIVERY LICENSEE MAY CONTRACT WITH ANOTHER
 - 24 INDEPENDENT DELIVERY LICENSEE TO SHARE A LICENSED PREMISES FOR
 - 25 THE PURPOSES OF STORING RETAIL MARIJUANA AND RETAIL MARIJUANA
 - 26 PRODUCTS, INCLUDING TRACKING AND RECORD-KEEPING REQUIREMENTS
 - 27 FOR SEPARATE INVENTORY; AND
 - 28 (V) PROCEDURES AND REQUIREMENTS FOR AN APPLICANT TO
 - 29 PROVIDE PROOF OF AN OBTAINED LICENSED PREMISES, INCLUDING AN
 - 30 AUTHORIZED STORAGE FACILITY.".
- 31 Page 7, line 29, strike "(5)(k)".
- 32 Page 7, strike lines 31 through 36.
- 33 Page 9, strike lines 4 through 13 and substitute:

1 **"repeal. (1) (a)** ON OR AFTER JANUARY 2, 2024, AND BEFORE JANUARY
2 1, 2028, THE STATE LICENSING AUTHORITY MAY ISSUE AN INDEPENDENT
3 DELIVERY LICENSE TO A PERSON WITH A SOCIAL EQUITY LICENSE
4 AUTHORIZING THE PERSON TO DELIVER AND SELL RETAIL MARIJUANA AND
5 RETAIL MARIJUANA PRODUCTS TO CONSUMERS AT THE CONSUMER'S
6 PRIVATE RESIDENCE PURSUANT TO THIS ARTICLE 10; RULES PROMULGATED
7 PURSUANT TO THIS ARTICLE 10; AND THE PROVISIONS OF THE ORDINANCE
8 OR RESOLUTION OF THE LOCAL JURISDICTION WHERE THE LICENSEE
9 OPERATES.".

10 Page 15, line 2, strike "SHALL" and substitute "MAY".

11 Page 15, line 3, strike "RETAIL MARIJUANA DELIVERY PERMITS" and
12 substitute "INDEPENDENT DELIVERY LICENSES".

13 Page 15, lines 4 and 5, strike "OCTOBER 31, 2023." and substitute
14 "JANUARY 2, 2024.".
