- 31 MARIJUANA OFFENSE HAS RECEIVED ASSISTANCE FROM AT LEAST ONE OF
- 32 THE PROGRAMS LISTED IN SUBSECTIONS (5)(b)(V)(A) TO (5)(b)(V)(E) OF
- 33 THIS SECTION FOR AT LEAST ANY FIVE OF THE TEN YEARS PRIOR TO
- 34 APPLICATION; OR
- 35 (IV) THE APPLICANT WAS A MEMBER OF THE MILITARY AND WAS
- 36 DISHONORABLY DISCHARGED BECAUSE THE APPLICANT WAS CONVICTED
- 37 OF A MARIJUANA OFFENSE; OR".
