Committee on Finance.

HB23-1020 be amended as follows:

1 Amend the Business Affairs & Labor Committee Report, dated February
2 23, 2023, page 7, line 3, strike "(16)" and substitute "(16); and **add**
3 (2)(d)".

4 Page 7, after line 4 insert:

5 "(2) (d) A RETAIL MARIJUANA STORE MAY SELL WHOLESALE RETAIL
6 MARIJUANA AND WHOLESALE RETAIL MARIJUANA PRODUCTS TO AN
7 INDEPENDENT DELIVERY LICENSEE."

8 Page 7, line 20, strike "(14)" and substitute "(14); and **add** (1)(f)".

9 Page 7, strike line 22 and substitute:

10 "**rules - definition.** (1) (f) A RETAIL MARIJUANA PRODUCTS
11 MANUFACTURER MAY SELL WHOLESALE RETAIL MARIJUANA AND
12 WHOLESALE RETAIL MARIJUANA PRODUCTS TO AN INDEPENDENT DELIVERY
13 LICENSEE.

14 (14) A retail marijuana products manufacturer".

15 Page 9, strike lines 14 through 20 and substitute:

16 "(b) AN INDEPENDENT DELIVERER MAY PURCHASE WHOLESALE
17 RETAIL MARIJUANA AND WHOLESALE RETAIL MARIJUANA PRODUCTS FROM
18 A RETAIL MARIJUANA STORE LICENSEE, AND THE INDEPENDENT DELIVERER
19 MAY PURCHASE WHOLESALE RETAIL MARIJUANA AND WHOLESALE RETAIL
20 MARIJUANA PRODUCTS FROM A RETAIL MARIJUANA PRODUCTS
21 MANUFACTURER LICENSEE."

22 Reletter succeeding paragraphs accordingly.

23 Page 9, lines 23 and 24, strike "CULTIVATION FACILITY" and substitute
24 "STORE".

25 Page 15, lines 38 and 39, strike "HOSPITALITY BUSINESS" and substitute
26 "INDEPENDENT DELIVERY".

27 Page 15, after line 39 insert:

28 "**SECTION 15.** In Colorado Revised Statutes, **add** 44-10-615 as
29 follows:

30 **44-10-615. Retail marijuana accelerator transporter license.**

31 (1) A RETAIL MARIJUANA ACCELERATOR TRANSPORTER LICENSE MAY BE
32 ISSUED TO A SOCIAL EQUITY LICENSEE TO EXERCISE THE PRIVILEGES OF A
33 RETAIL MARIJUANA TRANSPORTER LICENSEE ON THE PREMISES OF AN
34 ACCELERATOR-ENDORSED TRANSPORTER LICENSEE. THE RETAIL

1 MARIJUANA ACCELERATOR TRANSPORTER LICENSEE MAY RECEIVE
2 TECHNICAL ASSISTANCE AND FINANCIAL SUPPORT FROM THE RETAIL
3 MARIJUANA TRANSPORTER LICENSEE WITH AN ACCELERATOR
4 ENDORSEMENT.

5 (2) THE STATE LICENSING AUTHORITY MAY BEGIN ACCEPTING
6 APPLICATIONS FOR RETAIL MARIJUANA ACCELERATOR TRANSPORTER
7 LICENSES ON JANUARY 2, 2024."

8 Renumber succeeding sections accordingly.

9 Page 17, before line 1 insert:

10 "SECTION 19. In Colorado Revised Statutes, 39-28.8-202,
11 amend (1)(a)(I) as follows:

12 **39-28.8-202. Retail marijuana sales tax.** (1) (a) (I) In addition
13 to the tax imposed pursuant to part 1 of article 26 of this title 39 and the
14 sales tax imposed by a local government pursuant to title 29, 30, 31, or
15 32, but except as otherwise set forth in subsections (1)(a)(II) and
16 (1)(a)(III) of this section, beginning January 1, 2014, and through June
17 30, 2017, there is imposed upon all RETAIL sales of retail marijuana and
18 retail marijuana products by a retailer a tax at the rate of ten percent of the
19 amount of the sale. Beginning July 1, 2017, there is imposed upon all
20 sales of retail marijuana and retail marijuana products by a retailer a tax
21 at the rate of fifteen percent of the amount of the sale. The tax imposed
22 by this section is computed in accordance with schedules or forms
23 prescribed by the executive director of the department; except that a ~~retail~~
24 ~~marijuana store~~ RETAILER is not allowed to retain any portion of the retail
25 marijuana sales tax collected pursuant to this part 2 to cover the expenses
26 of collecting and remitting the tax. The executive director may
27 promulgate rules to implement this section."
