After consideration on the merits, the Committee recommends the following:

SB18-143 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 9, line 11, strike "Free" and substitute "Free
2 **8.00**".
- 3 Page 13, strike line 13 and substitute "not to exceed twenty-five dollars,
4 AS ESTABLISHED BY THE COMMISSION BY".
- 5 Page 15, line 9, after "BOTH." add "A NONPROFIT ORGANIZATION
6 GRANTED MONEY PURSUANT TO THIS SUBSECTION (3)(b) SHALL NOT USE
7 THE MONEY FOR LOBBYING OR ANY OTHER POLITICAL PURPOSE".
- 8 Page 16, line 2, strike "TWENTY-SIX" and substitute "TWENTY-TWO".
- 9 Page 16, line 19, strike "AND".
- 10 Page 16, strike line 23 and substitute "SECTION 2 OF SENATE BILL 18-143,
11 ENACTED IN 2018; AND
12 (C) A LIST OF NONPROFIT ORGANIZATIONS THAT, IN THE PREVIOUS
13 TWELVE MONTHS, RECEIVED GRANT MONEY FROM THE SALE OF STATE
14 MIGRATORY WATERFOWL STAMPS FOR IMPLEMENTATION OF THE NORTH
15 AMERICAN WATERFOWL MANAGEMENT PLAN PURSUANT TO SECTION
16 33-4-102.5 (3)(b) AND AN EXPLANATION OF EACH GRANT AWARD MADE".
- 17 Page 20, after line 8 insert:

1 **"SECTION 17.** In Colorado Revised Statutes, **add 33-12-106.5**
2 as follows:

3 **33-12-106.5. Alternative means of park entrance - fees -rules.**

4 (1) AN INDIVIDUAL ENTERING A STATE PARK OR STATE RECREATION AREA
5 BY MEANS OTHER THAN BY MOTOR VEHICLE MUST PURCHASE A PASS IN
6 ACCORDANCE WITH COMMISSION RULES.

7 (2) THE COMMISSION, BY RULE, SHALL ESTABLISH FEES FOR DAILY
8 AND ANNUAL PASSES FOR INDIVIDUALS ENTERING A STATE PARK OR STATE
9 RECREATION AREA BY MEANS OTHER THAN BY MOTOR VEHICLE. THE
10 COMMISSION MAY ESTABLISH EXEMPTIONS FROM SUCH FEES."

11 Renumber succeeding section accordingly.
