Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB18-145 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Business Labor and Technology Committee Report, dated
2 February 28, 2018, page 1, line 17, after the period insert "THE TIME
3 FRAMES ESTABLISHED IN THE DEPARTMENT'S RULES MUST PROVIDE FOR
4 TRAINING TO BE COMPLETED OVER A FIVE-YEAR PERIOD, SUBJECT TO THE
5 AVAILABILITY OF APPROPRIATIONS FOR REIMBURSEMENT OF VENDORS
6 PURSUANT TO SUBSECTION (3)(b)(III.5)(B) OF THIS SECTION."

7 Page 3, line 4, after the period insert "THE TIME FRAMES ESTABLISHED IN
8 THE STATE BOARD'S RULES MUST PROVIDE FOR TRAINING TO BE
9 COMPLETED OVER A FIVE-YEAR PERIOD, SUBJECT TO THE AVAILABILITY OF
10 APPROPRIATIONS FOR REIMBURSEMENT OF VENDORS PURSUANT TO
11 SUBSECTION (2)(k)(II) OF THIS SECTION."

12 Amend printed bill, page 9, after line 7 insert:

13 **"SECTION 7. Appropriation.** (1) For the 2018-19 state fiscal
14 year, \$27,675 is appropriated to the department of health care policy and
15 financing. This appropriation is from the general fund. To implement this
16 act, the department may use this appropriation as follows:

17 (a) \$22,972 for personal services, which amount is based on an
18 assumption that the department will require an additional 0.4 FTE; and

19 (b) \$4,703 for operating expenses.

20 (2) For the 2018-19 state fiscal year, \$2,131 is appropriated to the
21 department of labor and employment. This appropriation is from the

1 general fund. To implement this act, the department may use this
2 appropriation for the purchase of legal services.

3 (3) For the 2018-19 state fiscal year, \$2,131 is appropriated to the
4 department of law. This appropriation is from reappropriated funds
5 received from the department of labor and employment under subsection
6 (2) of this section. To implement this act, the department of law may use
7 this appropriation to provide legal services for the department of labor
8 and employment."

9 Renumber succeeding section accordingly.

10 Page 1, line 104, strike "**DISABILITIES.**" and substitute "**DISABILITIES,**
11 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**"
