Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB18-167 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Transportation Committee Report, dated February 22, 2018,
2 page 3, strike lines 29 and 30 and substitute:

3 "(XIV) ONE INDIVIDUAL NOMINATED BY THE COMMISSIONER OF
4 AGRICULTURE WHO IS ACTIVELY ENGAGED IN FARMING OR RANCHING."."

5 Amend printed bill, page 15, line 17, strike "1" and substitute "2".

6 Page 18 of the bill, line 10, strike "ARTICLE 1.5" and substitute "SECTION
7 AND SECTIONS 9-1.5-104.4, 9-1.5-104.7, AND 9-1.5-104.8".

8 Page 22 of the bill, after line 21 insert:

9 "(4) THE FOLLOWING ARE NOT SUBJECT TO A FINE OTHERWISE
10 AUTHORIZED PURSUANT TO THIS SECTION:

11 (a) WITH REGARD TO AN EXCAVATION OCCURRING ON A RANCH OR
12 FARM, A RANCHER OR A FARMER, AS DEFINED IN SECTION 42-20-108.5,
13 UNLESS THE EXCAVATION IS FOR A NONAGRICULTURAL PURPOSE; AND

14 (b) WITH REGARD TO A FAILURE TO NOTIFY THE NOTIFICATION
15 ASSOCIATION OR THE AFFECTED OWNER OR OPERATOR AND TO DAMAGE TO
16 AN UNDERGROUND FACILITY DURING EXCAVATION, A HOMEOWNER,
17 RANCHER, OR FARMER, AS DEFINED IN SECTION 42-20-108.5, WORKING ON
18 THE HOMEOWNER'S, RANCHER'S, OR FARMER'S PROPERTY."."

1 Page 28 of the bill, line 22, strike "1" and substitute "2".

2 Page 28 of the bill, after line 23 insert:

3 **"SECTION 8. Appropriation.** (1) For the 2018-19 state fiscal
4 year, \$81,841 is appropriated to the department of labor and employment.
5 This appropriation is from the general fund. To implement this act, the
6 department may use this appropriation as follows:

7 (a) \$69,054 for use by the division of oil and public safety for the
8 underground damage safety commission, which amount is based on an
9 assumption that the division will require an additional 0.8 FTE; and

10 (b) \$12,787 for the purchase of legal services.

11 (2) For the 2018-19 state fiscal year, \$12,787 is appropriated to
12 the department of law. This appropriation is from reappropriated funds
13 received from the department of labor and employment under subsection
14 (1)(b) of this section and is based on an assumption that the department
15 of law will require an additional 0.1 FTE. To implement this act, the
16 department of law may use this appropriation to provide legal services for
17 the department of labor and employment."

18 Renumber succeeding section accordingly.

19 Page 1, line 102, strike "FACILITIES." and substitute "FACILITIES, AND,
20 IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."
