After consideration on the merits, the Committee recommends the following:

HB19-1183 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 7, strike "REQUIRE" and substitute  
2 "ENCOURAGE".

3 Page 3 after line 21 insert:

4 "(b) IF A PUBLIC SCHOOL OR PUBLIC PLACE ACCEPTS A DONATED  
5 AED PURSUANT TO SUBSECTION (3)(a) OF THIS SECTION BUT THE PUBLIC  
6 SCHOOL OR PUBLIC PLACE DOES NOT WANT TO ACCEPT RESPONSIBILITY FOR  
7 AED TRAINING OR INSTALLATION OR FOR ENSURING THE AED IS IN  
8 COMPLIANCE WITH THE MANUFACTURER'S MAINTENANCE SCHEDULE, THE  
9 PUBLIC SCHOOL OR PUBLIC PLACE IS NOT REQUIRED TO ACCEPT THE AED  
10 UNLESS THE DONATING PARTY AGREES TO BE RESPONSIBLE FOR AED  
11 TRAINING, INSTALLATION, AND MAINTENANCE. THE PUBLIC SCHOOL OR  
12 PUBLIC PLACE SHALL DECIDE WHEN THE AED TRAINING AND  
13 INSTALLATION WILL TAKE PLACE. IF THE DONATING PARTY HAS ACCEPTED  
14 RESPONSIBILITY FOR THE MAINTENANCE OF THE AED BUT CAN NO LONGER  
15 PROVIDE MAINTENANCE, THE PUBLIC SCHOOL OR PUBLIC PLACE MAY  
16 EITHER ACCEPT RESPONSIBILITY FOR THE MAINTENANCE OF THE AED OR  
17 REMOVE THE AED FROM THE PUBLIC SCHOOL OR PUBLIC PLACE."

18 Reletter succeeding paragraph accordingly.

19 Page 4, strike lines 1 through 20.

20 Page 5, lines 2 and 3, strike "~~section 13-21-108.1, C.R.S.~~" and substitute

- 1 "section 13-21-108.1 ~~C.R.S.~~ AND".
- 2 Page 5, lines 4 and 5, strike "13-21-108.1 and".
