After consideration on the merits, the Committee recommends the following:

HB19-1197 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, line 3, strike "(1)(a), (1)(b)," and substitute
- 2 "(1)".

- 3 Page 2, line 6, strike "**social**".

- 4 Page 2, strike lines 7 through 11 and substitute:
- 5 "(a) "CASEWORKER" MEANS A STATE OR COUNTY EMPLOYEE,
- 6 INCLUDING A COUNTY ATTORNEY, WHO IS ENGAGED IN INVESTIGATING OR
- 7 TAKING LEGAL ACTION REGARDING ALLEGATIONS OF CHILD ABUSE OR
- 8 NEGLECT PURSUANT TO ARTICLE 3 OF TITLE 19.
- 9 (a) (b) "Immediate family" means a law enforcement official's OR
- 10 CASEWORKER'S spouse, child, or parent or any other blood relative who
- 11 lives in the same residence as the law enforcement official OR
- 12 CASEWORKER.
- 13 (a.5) (c) "Law enforcement official" means a peace officer as
- 14 described in section 16-2.5-101, ~~C.R.S.~~, a judge as defined by section
- 15 18-8-615 (3), or a prosecutor, as defined in section 18-8-616 (3).
- 16 (a.9) (d) "Participant in the address confidentiality program"
- 17 means an individual accepted into the address confidentiality program in
- 18 accordance with part 21 of article 30 of title 24. ~~C.R.S.~~
- 19 (b) (e) "Personal information" means the home address, home".

- 20 Page 3, strike lines 1 through 4.

1 Page 3, line 13, after "REQUEST" insert "PURSUANT TO SUBSECTION
2 (2.8)(b) OF THIS SECTION".

3 Page 3, line 14, after "REMOVE" insert "PERSONAL INFORMATION FROM".

4 Page 3, strike lines 15 through 18 and substitute "ARE AVAILABLE ON THE
5 INTERNET. IF A STATE OR LOCAL GOVERNMENT".

6 Page 4, strike lines 2 and 3 and substitute:

7 "(II) AN AFFIRMATION STATING UNDER PENALTY OF PERJURY THAT
8 THE PERSON HAS REASON TO BELIEVE THAT THE DISSEMINATION OF THE
9 PERSONAL INFORMATION CONTAINED IN THE RECORDS THAT THE
10 OFFICIAL".

11 Page 4, strike lines 18 and 19 and substitute:

12 "(XXII) PERSONAL INFORMATION, AS DEFINED IN SECTION
13 18-9-313 (1)(e), IN A RECORD FOR WHICH THE CUSTODIAN HAS RECEIVED
14 A REQUEST UNDER SECTION 18-9-313."

15 Strike "SOCIAL" on: **Page 2**, lines 14, 16, and 19; **Page 3**, lines 6, 7, 9, 10,
16 13, 21, 22, 23, and 27; and **Page 4**, lines 5 and 6.
