After consideration on the merits, the Committee recommends the following:

HB20-1074 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, strike lines 10 through 14 and substitute "may
2 provide collection and transportation of solid waste, INCLUDING
3 RESIDENTIAL WASTE SERVICES AS DEFINED IN SECTION 30-15-401 (7.5)(d),
4 for and on behalf of the district, including but not limited to the financing
5 thereof, ~~If the board decides to provide collection and transportation of~~
6 ~~solid waste~~ BY EITHER CONTRACTING WITH A THIRD-PARTY SERVICE
7 PROVIDER PURSUANT TO THIS SECTION OR PROVIDING SUCH WASTE
8 SERVICES PURSUANT TO SECTION 30-15-401 (7.5)(d) AND (7.7). THE
9 BOARD MAY IMPOSE FEES, RATES, PENALTIES, OR CHARGES FOR SUCH
10 SERVICE PURSUANT TO SECTION 32-1-1001 (1)(j)(I), AND THE BOARD MAY
11 REQUIRE THAT THE DISTRICT RESIDENTS USE OR PAY USER CHARGES FOR
12 RESIDENTIAL WASTE SERVICES. IF THE BOARD CONTRACTS WITH A
13 THIRD-PARTY SERVICE PROVIDER, THE BOARD SHALL PUBLISH A NOTICE
14 FOR BIDS OR A REQUEST FOR PROPOSALS NO LESS THAN THIRTY DAYS PRIOR
15 TO AWARDING THE CONTRACT. IF THE BOARD DECIDES TO PROCEED WITH
16 ITS OWN PROPOSAL TO DIRECTLY PROVIDE RESIDENTIAL WASTE SERVICES
17 RATHER THAN ENTER INTO A CONTRACT WITH A THIRD-PARTY SERVICE
18 PROVIDER, the board shall request proposals to provide".

19 Page 2, line 18, strike "MAY REQUIRE".

20 Page 2, strike lines 19 through 21 and substitute "MAY NOT PROVIDE
21 COLLECTION AND TRANSPORTATION OF SOLID WASTE SERVICES WITHIN THE
22 BOUNDARIES OF ANY MUNICIPALITY, CITY AND COUNTY, OR COUNTY THAT

1 IS PROVIDING SOLID WASTE SERVICES, WITHOUT THE CONSENT OF THE
2 MUNICIPALITY, CITY AND COUNTY, OR COUNTY.".
