## CONCERNING CHANGES TO THE JOINT RULES OF THE SENATE AND HOUSE OF REPRESENTATIVES REGARDING EQUAL ACCESS TO LEGISLATIVE PROCEEDINGS.

Be It Resolved by the Senate of the Seventy-second General Assembly of the State of Colorado, the House of Representatives concurring herein:

That in the Joint Rules of the Senate and House of Representatives, Rule No. 43, **amend** (a) (3) as follows:

## 43. Equal Access to Legislative Proceedings

- (a) All meetings, hearings, and other proceedings of the general assembly, or either house thereof or any committee thereof, shall be conducted in a manner to ensure, at a minimum:
  - (3) That requests by persons with disabilities for reasonable accommodations and for auxiliary aids and services made in connection with such meetings, hearings, or other proceedings are satisfied to the greatest extent possible consistent with the "Legislative Branch Policy on Services"
