HB21-1265 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 4, after "(1.3)(a)(I.5)," insert
2 "(1.3)(a)(I.7),".

3 Page 3, after line 8 insert:

4 "(I.7) "HOTEL-OPERATED RESTAURANT, BAR, OR CATERING
5 SERVICE" MEANS A RESTAURANT OR OTHER EATING PLACES INDUSTRY
6 ESTABLISHMENT OR AN ALCOHOLIC BEVERAGES DRINKING PLACES
7 INDUSTRY ESTABLISHMENT LOCATED ON THE PREMISES OF AN
8 ESTABLISHMENT PRIMARILY ENGAGED IN PROVIDING SHORT-TERM
9 LODGING FACILITIES AND KNOWN AS A HOTEL, MOTOR HOTEL, RESORT
10 HOTEL, MOTEL, BED-AND-BREAKFAST INN, TOURIST HOME, GUEST HOUSE,
11 YOUTH HOSTEL, OR HOUSEKEEPING CABIN, INCLUDING A HOTEL FACILITY
12 WITH A CASINO ON THE PREMISES. "HOTEL-OPERATED RESTAURANT, BAR,
13 OR CATERING SERVICE" INCLUDES THE SALE OF SINGLE EVENT-BASED FOOD
14 SERVICES DESCRIBED IN SUBSECTION (1.3)(a)(I.3) OF THIS SECTION ON THE
15 PREMISES OF THE ESTABLISHMENT. "HOTEL-OPERATED RESTAURANT, BAR,
16 OR CATERING SERVICE" DOES NOT INCLUDE SALES OF ROOMS OR
17 ACCOMMODATIONS, GIFTS AND SUNDRIES, RECREATIONAL SERVICES,
18 CONFERENCE ROOMS, CONVENTION SERVICES, LAUNDRY SERVICES,
19 PARKING, AND OTHER SERVICES."

20 Page 3, line 23, strike "SERVICES INDUSTRY." and substitute "SERVICES
21 INDUSTRY, OR THAT OPERATES A HOTEL-OPERATED RESTAURANT, BAR, OR

1 CATERING SERVICE.".

2 Page 4, line 9, strike "OR".

3 Page 4, line 10, strike "INDUSTRY" and substitute "INDUSTRY, OR
4 OPERATING A HOTEL-OPERATED RESTAURANT, BAR, OR CATERING
5 SERVICE".

6 Page 4, line 18, strike "OR".

7 Page 4, line 19, strike "INDUSTRY." and substitute "INDUSTRY, OR
8 OPERATING A HOTEL-OPERATED RESTAURANT, BAR, OR CATERING
9 SERVICE".
