Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB21-1314 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Judiciary Committee Report, dated May 19, 2021, page 3,
2 strike line 12, and substitute:

3 "Page 18, strike lines 12 through 14 and substitute:".

4 Page 3 of the report, line 14, before "(4.7)" insert "(2)(b)(IV)(S) and".

5 Page 3 of the report, line 16, strike "(4.7) (a) ON JULY 31, 2021, AND ON"
6 and substitute "(2) (b) (IV) Subject to the limitation in subsection (5) of
7 this section, the general assembly may annually appropriate any money
8 in the fund for the following purposes:
9 (S) FOR TRIAL COURT PROGRAMS ADMINISTERED BY THE JUDICIAL
10 DEPARTMENT.
11 (4.7) (a) ON JULY 1, 2022, AND ON".

12 Page 3 of the report, line 21, after "DIVISION;" add "AND".

13 Page 3 of the report, line 24, strike "VEHICLES; AND" and substitute
14 "VEHICLES."

15 Page 3 of the report, strike lines 25 through 27.

16 Page 3 of the report, strike lines 29 through 31 and substitute "TWO
17 HUNDRED ELEVEN THOUSAND FIVE HUNDRED DOLLARS FROM THE FUND TO

1 THE LICENSING SERVICES CASH FUND CREATED IN SECTION 42-2-114.5
2 FOR".

3 Page 3 of the report, strike line 34 and substitute "2022.

4 (c) (I) ON JANUARY 1, 2022, THE STATE TREASURER SHALL MAKE
5 THE FOLLOWING TRANSFERS FROM THE FUND:

6 (A) THREE HUNDRED SEVENTY-SIX THOUSAND FIVE HUNDRED
7 DOLLARS TO THE LICENSING SERVICES CASH FUND CREATED IN SECTION
8 42-2-114.5 FOR USE BY THE HEARINGS DIVISION; AND

9 (B) THREE HUNDRED TWENTY-FOUR THOUSAND DOLLARS TO THE
10 LICENSING SERVICES CASH FUND CREATED IN SECTION 42-2-114.5 FOR USE
11 BY THE DIVISION OF MOTOR VEHICLES.

12 (II) THIS SUBSECTION (4.7)(c) IS REPEALED, EFFECTIVE JUNE 30,
13 2022."."

14 Page 3 of the report, before line 35 insert:

15 "Page 18 of the bill, before line 15, insert:

16 **SECTION 19. Appropriation.** For the 2021-22 state fiscal year,
17 \$211,500 is appropriated to the department of revenue for use by the
18 division of motor vehicles. This appropriation is from the licensing
19 services cash fund created in section 42-2-114.5 (1), C.R.S. To implement
20 this act, the division may use this appropriation for DRIVES maintenance
21 and support.

22 **SECTION 20. Appropriation - adjustments to 2021 long bill.**

23 (1) To implement this act, the cash funds appropriation from
24 various fees and cost recoveries made in the annual general appropriation
25 act for the 2021-22 state fiscal year to the judicial department for trial
26 court programs is decreased by \$1,107,723.

27 (2) For the 2021-22 state fiscal year, \$1,107,723 is appropriated
28 to the judicial department. This appropriation is from the marijuana tax
29 cash fund created in section 39-28.8-501 (1), C.R.S. To implement this
30 act, the department may use this appropriation for trial court programs.

31 **SECTION 21. Effective date - applicability.** (1) This act takes
32 effect upon passage; except that sections 1 through 17 of this act take
33 effect January 1, 2022.

34 (2) This act applies to offenses committed and applications
35 submitted on or after the applicable effective date of this act."."

36 Page 3 of the report, after line 35, insert:



- 1 "Page 1, line 102, strike "DOCUMENTS." and substitute "DOCUMENTS,
- 2 AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."."
