After consideration on the merits, the Committee recommends the following:

SB21-292 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, page 6, after line 16 insert:

2 "SECTION 2. In Colorado Revised Statutes, 14-4-107, add (4)(c)  
3 as follows:

4 **14-4-107. Family violence justice fund - creation - grants from**  
5 **fund - definitions.** (4) (c) (I) IN ADDITION TO THE MONEY PAID INTO THE  
6 FUND PURSUANT TO THIS SUBSECTION (4) AND SUBSECTION (4.5) OF THIS  
7 SECTION, THE GENERAL ASSEMBLY SHALL APPROPRIATE MONEY FROM THE  
8 ECONOMIC RECOVERY AND RELIEF CASH FUND, CREATED IN SECTION  
9 24-75-228, AS ENACTED BY SENATE BILL 21-291, ENACTED IN 2021, TO  
10 THE OFFICE OF THE STATE COURT ADMINISTRATOR TO BE USED FOR THE  
11 PROGRAMS AND PURPOSES DESCRIBED IN SUBSECTION (2) OF THIS SECTION.

12 (II) MONEY APPROPRIATED PURSUANT TO SUBSECTION (4)(c)(I) OF  
13 THIS SECTION FROM THE ECONOMIC RECOVERY AND RELIEF CASH FUND,  
14 CREATED IN SECTION 24-75-228, AS ENACTED BY SENATE BILL 21-291,  
15 ENACTED IN 2021, MUST ONLY FUND PROGRAMS AND PURPOSES THAT ALSO  
16 CONFORM WITH THE ALLOWABLE PURPOSES SET FORTH IN THE FEDERAL  
17 "AMERICAN RESCUE PLAN ACT OF 2021", PUB.L. 117-2, AS THE ACT MAY  
18 BE SUBSEQUENTLY AMENDED. THE OFFICE OF THE STATE COURT  
19 ADMINISTRATOR MAY USE UP TO TEN PERCENT OF ANY MONEY  
20 APPROPRIATED PURSUANT TO SUBSECTION (4)(c)(I) OF THIS SECTION FOR  
21 DEVELOPMENT AND ADMINISTRATIVE COSTS INCURRED PURSUANT TO THIS  
22 SECTION IN THE PROVISION OF PROGRAMS AND SERVICES ALLOWED  
23 PURSUANT TO THE FEDERAL "AMERICAN RESCUE PLAN ACT OF 2021",

- 1 PUB.L. 117-2, AS THE ACT MAY BE SUBSEQUENTLY AMENDED."
- 2 Renumber succeeding sections accordingly.
- 3 Page 13, line 13, strike "\$3,500,000" and substitute "\$3,000,000".
- 4 Page 14, line 2, strike "Colorado" and substitute "victims assistance and
- 5 law enforcement fund".
- 6 Page 14, line 3, strike "domestic abuse program fund".
- 7 Page 14, line 13, strike "\$5,000,000" and substitute "\$4,750,000".
- 8 Page 14, line 20, strike "\$5,000,000" and substitute "\$4,750,000".
- 9 Page 14, after line 25 insert:  
  
10 "(9) For the 2021-22 state fiscal year, \$750,000 is appropriated to  
11 the judicial department for use by courts administration. This  
12 appropriation is from the economic recovery and relief cash fund created  
13 in section 24-75-228, C.R.S., and of money the state received from the  
14 federal coronavirus state fiscal recovery fund. To implement this act, the  
15 department may use this appropriation for family violence justice grants."
