- (b) "NATIONAL BOARD-CERTIFIED EDUCATOR" MEANS:
- (I) BEGINNING WITH THE 2009-10 BUDGET YEAR, TEACHERS AND SCHOOL COUNSELORS WHO HOLD A CERTIFICATION FROM THE NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS AND SCHOOL COUNSELORS WHO HOLD A CERTIFICATION FROM THE NATIONAL BOARD FOR CERTIFIED COUNSELORS;
- (II) BEGINNING WITH THE 2019-20 BUDGET YEAR, NATIONALLY CERTIFIED SCHOOL PSYCHOLOGISTS WHO HOLD A CERTIFICATION FROM THE NATIONAL ASSOCIATION OF SCHOOL PSYCHOLOGISTS; AND
- (III) BEGINNING WITH THE 2023-24 BUDGET YEAR, LIBRARIANS WHO HOLD A CERTIFICATION FROM THE NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS AND NATIONALLY CERTIFIED SCHOOL SOCIAL WORKERS WHO HOLD A CERTIFICATION FROM THE NATIONAL ASSOCIATION OF SOCIAL WORKERS OR THE SCHOOL SOCIAL WORK ASSOCIATION OF AMERICA.
- (c) "RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT IN COLORADO THAT THE DEPARTMENT DETERMINES IS RURAL, BASED ON THE GEOGRAPHIC SIZE OF THE SCHOOL DISTRICT AND THE DISTANCE OF THE SCHOOL DISTRICT FROM THE NEAREST LARGE, URBANIZED AREA, AND THE TOTAL STUDENT ENROLLMENT IS SIX THOUSAND FIVE HUNDRED STUDENTS OR FEWER.".
