After consideration on the merits, the Committee recommends the following:

HB24-1019 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, after line 26 insert:
- 2       "(B) IN-HOME SERVICES;"
- 3 Reletter succeeding sub-subparagraphs accordingly.
- 4 Page 5, strike line 17 and substitute "COMMUNITY PARTNERS, AS
- 5 INDICATED BY A MEMORANDUM OF UNDERSTANDING AND ACTIVE
- 6 PARTICIPATION ON EXISTING MULTIDISCIPLINARY PROBLEM-SOLVING
- 7 COMMUNITY ROUNDTABLES, SUCH AS INTERAGENCY OVERSIGHT GROUPS
- 8 THAT DETERMINE COLLABORATIVE MANAGEMENT PROGRAM PROCESSES,
- 9 COMMUNITY PREVENTION PROGRAMS, OR LOCAL JUVENILE SERVICES
- 10 PLANNING COMMITTEES. COMMUNITY PARTNERS INCLUDE:"
- 11 Page 6, line 14, strike "AND".
- 12 Page 6, after line 18 insert:
- 13       "(B) DETERMINE COSTS TO PROVIDE SERVICES TO CHILDREN AND
- 14 YOUTH FOR UP TO EIGHT WEEKS;
- 15       (C) ALLOW ACCESS TO THE PROGRAM FOR CHILDREN OR YOUTH
- 16 WITHOUT A BEHAVIORAL HEALTH DIAGNOSIS;
- 17       (D) DETERMINE HOW TO ALIGN THE PROGRAM WITH THE
- 18 EVIDENCE-BASED YOUTH MOBILE RESPONSE AND STABILIZATION SERVICES
- 19 MODEL;"
- 20 Reletter succeeding sub-subparagraphs accordingly.

1 Page 6, line 22, strike "PROGRAM." and substitute "PROGRAM; AND".

2 Page 6, after line 22 insert:

3 "(VII) DEVELOP A SURVEY FOR CHILDREN OR YOUTH AND THEIR  
4 CAREGIVERS WHO PARTICIPATE IN THE PROGRAM FOR THE BHA TO  
5 MEASURE SATISFACTION WITH PROGRAM SERVICES AND OUTCOMES. THE  
6 BHA MAY INCLUDE OTHER INFORMATION IN THE SURVEY AS NECESSARY.  
7 THE BHA SHALL DISTRIBUTE THE SURVEY TO CHILDREN AND YOUTH AND  
8 THEIR CAREGIVERS AS SOON AS REASONABLY POSSIBLE AFTER THE  
9 DISCONTINUATION OF CRISIS RESOLUTION TEAM PROVIDER SERVICES. THE  
10 BHA MAY REDISTRIBUTE THE SURVEY TO CHILDREN OR YOUTH AND THEIR  
11 CAREGIVERS AFTER A PERIOD OF SIX MONTHS. THE BHA SHALL COLLECT  
12 SURVEY RESULTS AND INCLUDE THE RESULTS AS PART OF THE REPORT  
13 DESCRIBED IN SUBSECTION (6)(a)(II) OF THIS SECTION."

14 Page 6, line 25, strike "PUBLIC AND BEHAVIORAL".

15 Page 7, after line 24 insert:

16 "(III) NOTWITHSTANDING THE REQUIREMENT IN SECTION 24-1-136  
17 (11)(a)(I), THE REQUIREMENT TO SUBMIT THE REPORT REQUIRED IN THIS  
18 SUBSECTION (6) CONTINUES INDEFINITELY."
