HB24-1021 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 2, strike "a person" and substitute "a
2 ~~person~~ AN INDIVIDUAL".
- 3 Page 3, line 3, strike "person" and substitute "~~person~~ INDIVIDUAL".
- 4 Page 3, line 7, strike "person" and substitute "~~person~~ INDIVIDUAL".
- 5 Page 3, strike lines 12 and 13 and substitute:
6 "(A) The ~~person's parent or guardian or by a responsible adult~~
7 INDIVIDUAL WHO SIGNED THE AFFIDAVIT OF LIABILITY FOR THE
8 INDIVIDUAL TO OBTAIN AN INSTRUCTION PERMIT;"
- 9 Page 3, strike line 27 and substitute "DIRECTED BY A DRIVING SUPERVISOR
10 LISTED IN SECTION 42-2-106 (2)(b)(II)".
- 11 Page 4, strike line 1.
- 12 Page 5, line 2, strike "TWENTY-ONE" and substitute "EIGHTEEN".
- 13 Page 5, line 15, strike "SECTIONS 42-2-107 AND 42-2-108." and substitute
14 "SECTION 42-2-107".
- 15 Page 11, line 4, strike "A COMMERCIAL DRIVING SCHOOL" and substitute
16 "THE DEPARTMENT".
- 17 Page 12, line 1, strike "COMMERCIAL DRIVING SCHOOL," and substitute
18 "DEPARTMENT,".

1 Page 12, strike line 7 and substitute "DEPARTMENT, AND THE
2 DEPARTMENT".

3 Page 12, lines 9 and 10, strike "COMMERCIAL DRIVING SCHOOL" and
4 substitute "DEPARTMENT".

5 Page 12, line 18, strike "COMMERCIAL DRIVING SCHOOL," and substitute
6 "DEPARTMENT AND THE DEPARTMENT SHALL INFORM THE COMMERCIAL
7 DRIVING SCHOOL,".

8 Page 12, line 19, after "SHALL" insert "REQUIRE THE COMMERCIAL
9 DRIVING INSTRUCTOR TO".

10 Page 12, lines 25 and 26, strike "COMMERCIAL DRIVING SCHOOL" and
11 substitute "DEPARTMENT".

12 Page 13, strike lines 1 though 3 and substitute:

13 "(VII) THE DEPARTMENT SHALL NOTIFY THE COMMERCIAL DRIVING
14 SCHOOL WHETHER THE COMMERCIAL DRIVING INSTRUCTOR QUALIFIES OR
15 IS DISQUALIFIED".
