HB24-1021 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 2, line 3, strike "(4)(a); **repeal** (5); and **add**
- 2 (5.5)" and substitute "(4)(a)".
- 3 Page 3, line 5, strike "~~and~~" and substitute "and".
- 4 Page 3, line 19, strike "child;" and substitute "child.".
- 5 Page 3, strike lines 20 through 27.
- 6 Page 4, strike lines 1 through 24.
- 7 Page 5, lines 4 and 5, strike "COMPLETED, WITHIN THE PREVIOUS SIX
- 8 MONTHS," and substitute "COMPLETED".
- 9 Page 5, after line 23 insert:
- 10 "(d) THE DEPARTMENT SHALL ISSUE AN INSTRUCTION PERMIT TO
- 11 A MINOR WHO IS EIGHTEEN YEARS OF AGE OR OLDER AND WHO MEETS THE
- 12 REQUIREMENTS TO BE ISSUED AN INSTRUCTION PERMIT IN ACCORDANCE
- 13 WITH SECTIONS 42-2-107 AND 42-2-108.
- 14 (e) THE DEPARTMENT SHALL NOT ISSUE AN INSTRUCTION PERMIT
- 15 TO DRIVE A MOTORCYCLE UNLESS THE APPLICANT HAS SUCCESSFULLY
- 16 COMPLETED AN INSTRUCTION PROGRAM IN MOTORCYCLE SAFETY THAT IS
- 17 APPROVED BY THE COLORADO STATE PATROL.".
- 18 Page 6, line 4, strike "PERSONS" and substitute "INDIVIDUALS".
- 19 Page 6, line 16, strike "A PERSON" and substitute "AN INDIVIDUAL".

- 1 Page 6, line 20, strike "A PERSON" and substitute "AN INDIVIDUAL".
- 2 Page 6, line 22, strike "THE PERSON" and substitute "AN INDIVIDUAL".
- 3 Page 6, strike line 23 and substitute "WHO ASSUMED THE OBLIGATIONS
4 UNDER THIS ARTICLE 2 BY SIGNING THE AFFIDAVIT OF LIABILITY FOR THE
5 MINOR."
- 6 Page 6, line 27, strike "PERSON" and substitute "INDIVIDUAL".
- 7 Page 7, strike lines 3 through 5 and substitute:
- 8 "(d) THE INDIVIDUAL WHO SIGNED THE AFFIDAVIT OF LIABILITY
9 MAY ALLOW".
- 10 Page 7, strike lines 11 through 14 and substitute:
- 11 "(e) (I) IF THE INDIVIDUAL WHO SIGNED THE AFFIDAVIT OF
12 LIABILITY DOES NOT HAVE A".
- 13 Page 7, line 15, strike "PERSON" and substitute "INDIVIDUAL".
- 14 Page 7, strike lines 17 through 20 and substitute:
- 15 "(II) IF THE INDIVIDUAL WHO COSIGNED THE APPLICATION FOR THE
16 MINOR'S INSTRUCTION PERMIT IS IN THE UNITED".
- 17 Page 7, line 22, strike "PERSON" and substitute "INDIVIDUAL".
- 18 Page 7, line 23, strike "PERSON" and substitute "INDIVIDUAL".
- 19 Page 13, line 15, strike "January 1, 2027;" and substitute "April 1, 2026;".
- 20 Page 13, line 21, strike "January 1, 2027," and substitute "April 1, 2026,".
- 21 Page 13, lines 25 and 26, strike "the applicable effective date of this act."
22 and substitute "April 1, 2026."
