HB24-1270 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 5, line 21, strike "OR".
- 2 Page 5, after line 21 insert:
 - 3 "(II) WOULD SUFFER UNDUE FINANCIAL HARDSHIP PARTICULAR TO
 - 4 THE PERSON'S SPECIFIC FINANCIAL SITUATION AS A RESULT OF OBTAINING
 - 5 INSURANCE COVERAGE REQUIRED PURSUANT TO SUBSECTION (1) OF THIS

- 9 Page 6, line 7, strike "OR".
- 10 Page 6, after line 7 insert:
 - 11 "(II) A PERSON WHO WOULD SUFFER UNDUE FINANCIAL HARDSHIP
 - 12 PARTICULAR TO THE PERSON'S SPECIFIC FINANCIAL SITUATION AS A RESULT
 - 13 OF OBTAINING INSURANCE COVERAGE REQUIRED PURSUANT TO
 - 14 SUBSECTION (1) OF THIS SECTION AND THE PERSON PRESENTS EVIDENCE OF
 - 15 THE UNDUE FINANCIAL HARDSHIP; OR".
- 16 Renumber succeeding subparagraph accordingly.
- 17 Page 6, line 24, strike "OR".
- 18 Page 6, after line 24 insert:
 - 19 "(B) WOULD SUFFER UNDUE FINANCIAL HARDSHIP PARTICULAR TO
 - 20 THE PERSON'S SPECIFIC FINANCIAL SITUATION AS A RESULT OF OBTAINING
 - 21 INSURANCE COVERAGE REQUIRED PURSUANT TO SUBSECTION (1) OF THIS

- 1 SECTION; OR".
- 2 Reletter succeeding sub-subparagraph accordingly.
- 3 Page 7, line 10, strike "(I)".
- 4 Page 7, line 17, strike "(II)" and substitute "(9)" and strike "SUBSECTION
- 5 (8)," and substitute "SECTION,".
- 6 Renumber succeeding subsection accordingly.
