After consideration on the merits, the Committee recommends the following:

SB24-173 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend reengrossed bill, page 8, line 21, strike "OBTAIN" and substitute
2 "MAY BE ISSUED".

3 Page 8, strike lines 25 through 27 and substitute:

4 "(b) AN INDIVIDUAL WHO HOLDS A PROVISIONAL LICENSE MAY BE
5 ISSUED A FULL LICENSE FOR THE SAME PRACTICE AS LISTED ON THE
6 INDIVIDUAL'S PROVISIONAL LICENSE IF:

7 (I) THE INDIVIDUAL HAS RECEIVED WORKPLACE LEARNING
8 EXPERIENCE OF AT LEAST ONE YEAR SUPERVISED BY A QUALIFIED MENTOR,
9 IN ADDITION TO THE WORKPLACE LEARNING EXPERIENCE REQUIREMENT
10 DESCRIBED IN SUBSECTION (4)(b)(II) OF THIS SECTION;

11 (II) THE INDIVIDUAL HAS OBTAINED A CRIMINAL HISTORY RECORD
12 CHECK IN ACCORDANCE WITH SECTION 12-135-502 AND DOES NOT HAVE
13 A DISQUALIFYING CRIMINAL HISTORY OR OTHER DISQUALIFIER PURSUANT
14 TO SECTION 12-135-503;

15 (III) (A) NOTWITHSTANDING SECTION 12-135-603, THE
16 INDIVIDUAL HAS DEMONSTRATED, IN A MANNER DETERMINED BY THE
17 DIRECTOR, THAT THE INDIVIDUAL HAS DIRECTED NO FEWER THAN
18 TWENTY-FIVE FUNERALS;

19 (B) NOTWITHSTANDING SECTION 12-135-703, THE INDIVIDUAL HAS
20 DEMONSTRATED, IN A MANNER DETERMINED BY THE DIRECTOR, THAT THE
21 INDIVIDUAL HAS DIRECTED NO FEWER THAN TWENTY-FIVE FUNERALS AND
22 EMBALMED NO FEWER THAN TWENTY-FIVE HUMAN REMAINS; OR

23 (C) NOTWITHSTANDING SECTION 12-135-803, THE INDIVIDUAL HAS
24 DEMONSTRATED, IN A MANNER DETERMINED BY THE DIRECTOR, THAT THE
25 INDIVIDUAL HAS EMBALMED NO FEWER THAN TWENTY-FIVE HUMAN
26 REMAINS.

27 (c) A QUALIFIED MENTOR SHALL PROVIDE A REPORT TO THE

1 PROVISIONAL LICENSEE AND THE DIRECTOR. THE REPORT MUST ATTEST TO
2 WHETHER THE PROVISIONAL LICENSEE COMPLETED THE REQUIREMENTS
3 DESCRIBED IN SUBSECTION (5)(b) OF THIS SECTION IN COMPLIANCE WITH
4 THIS ARTICLE 135, WHETHER THE PROVISIONAL LICENSEE PRACTICED
5 ETHICALLY, AND WHETHER THE QUALIFIED MENTOR WOULD RECOMMEND
6 THE PROVISIONAL LICENSEE BE ISSUED A FULL LICENSE. TO ISSUE A
7 LICENSE PURSUANT TO SUBSECTION (5)(b) OF THIS SECTION, THE DIVISION
8 MUST HAVE RECEIVED THE REPORT FROM THE QUALIFIED MENTOR."

9 Page 9, strike lines 1 and 2.
