After consideration on the merits, the Committee recommends the following:

SB24-183 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 4, line 25, strike "THIRTEEN" and substitute
- 2 "SEVENTEEN".

- 3 Page 5, line 12, strike "OR WHO HAS RECENTLY".

- 4 Page 5, line 13, strike "SERVED" and strike "CLERK," and substitute
- 5 "CLERK OR AN INDIVIDUAL WHO HAS EXPERTISE RELATED TO MOBILE
- 6 HOME POLICY,".

- 7 Page 5, line 15, strike "TWO" and substitute "THREE".

- 8 Page 5, line 23, strike "AND".

- 9 Page 5, strike line 26 and substitute "REVENUE;
- 10 (XI) A REPRESENTATIVE OF THE BANKING INDUSTRY, APPOINTED
- 11 BY THE COLORADO BANKERS ASSOCIATION; AND
- 12 (XII) TWO COUNTY COMMISSIONERS, ONE FROM AN URBAN
- 13 COUNTY APPOINTED BY THE MINORITY LEADER OF THE SENATE AND ONE
- 14 FROM A RURAL COUNTY APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 15 REPRESENTATIVES.".

- 16 Page 7, line 16, strike "CONCERNING" and substitute "INCLUDING".

- 17 Page 8, after line 2 insert:
- 18 "(c) THE DIVISION SHALL WORK WITH THE OFFICE OF INFORMATION
- 19 TECHNOLOGY, CREATED IN THE OFFICE OF THE GOVERNOR PURSUANT TO
- 20 SECTION 24-37.5-103 (1), TO DEVELOP THE INITIAL SCOPE OF WORK FOR A
- 21 SYSTEM FOR TITLING AND REGISTERING MOBILE HOMES, INCLUDING TINY

1 HOMES, AND SHALL CONSULT WITH THE TASK FORCE REGARDING THE
2 DEVELOPMENT OF THIS SYSTEM."

3 Page 8, line 3, strike "HOUSE OF".

4 Page 8, strike lines 4 and 5.

5 Page 8, line 6, strike "COMMITTEE, OR THEIR SUCCESSOR COMMITTEES,"
6 and substitute "LEGISLATIVE OVERSIGHT COMMITTEE CONCERNING TAX
7 POLICY, OR A SUCCESSOR COMMITTEE,".
