#### A BILL FOR AN ACT

101	CONCERNING A MODIFICATION OF THE DATES ON WHICH THE
102	REQUIRED PERFORMANCE AUDITS OF CERTAIN GOVERNMENTAL
103	ENTITIES ARE DUE.

### **Bill Summary**

Legislative Audit Committee. Current law requires the state auditor to conduct a performance audit of the department of personnel (department) and the state personnel board (board) every 4 years. The next audit of the department and the board is due by December 1, 2016.

SENATE Reading Unamended February 29, 2016 a new statewide human resources information system (system), with the target "go live" date of July 1, 2017. It is likely that many of the potential findings of the audit will already be corrected with the new system, so conducting the audit just prior to the implementation of the new system would not be the most efficient use of resources. In addition, the most recent audits of the department and the board have not found areas of high risk or significant new cost savings for the department or the board.

The bill changes the date on which the next audit of the department and the board is due to December 1, 2019, which is after the implementation of the new system. The bill also removes the 4-year audit requirement and leaves future audits to the discretion of the state auditor.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 SECTION 1. In Colorado Revised Statutes, 24-50-103.5, amend 3 (2) as follows: 4 **24-50-103.5.** Department of personnel - review. (2) (a) The 5 legislative audit committee shall cause to be conducted a performance 6 audit of the department and the board. The performance audit shall be 7 completed at least seven months prior to July 1, 1981. In conducting the 8 audit, the legislative audit committee shall take into consideration, but not 9 be limited to considering, the factors listed in paragraph (b) of subsection 10 (3) of this section. Upon completion of the audit report, the legislative 11 audit committee shall hold a public hearing for purposes of review of the 12 report. 13 (b) A further performance audit as required in this section shall be 14 completed at least seven months before July 1, 1985, and every four years 15 thereafter July 1, 2020, and shall be completed thereafter at the 16 DISCRETION OF THE STATE AUDITOR.

**SECTION 2.** Act subject to petition - effective date. This act
