1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 12-60-901 as  
3 follows:

4 **12-60-901. Repeal of article - review of functions.** (1) This  
5 article is repealed, effective ~~July~~ SEPTEMBER 1, 2016 2023. Prior to ~~such~~  
6 THE repeal, the division and its functions shall be reviewed as provided  
7 for in section 24-34-104, C.R.S.

8 **SECTION 2.** In Colorado Revised Statutes, 24-34-104, **repeal**  
9 (47) (b); and **add** (54) (b) as follows:

10 **24-34-104. General assembly review of regulatory agencies**  
11 **and functions for termination, continuation, or reestablishment.**

12 (47) The following agencies, functions, or both, shall terminate on July  
13 1, 2016:

14 (b) ~~The division of racing events, including the Colorado racing~~  
15 ~~commission created by article 60 of title 12, C.R.S.;~~

16 (54) The following agencies, functions, or both, terminate on  
17 September 1, 2023:

18 (b) THE DIVISION OF RACING EVENTS, INCLUDING THE COLORADO  
19 RACING COMMISSION, CREATED BY ARTICLE 60 OF TITLE 12, C.R.S.

20 **SECTION 3. Safety clause.** The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, and safety.
