1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-47-406, **add** (1)
3 (f) as follows:

4 **12-47-406. Wholesaler's license.** (1)(f) NOTWITHSTANDING ANY
5 PROVISION OF THIS ARTICLE TO THE CONTRARY, A WHOLESALER LICENSED
6 PURSUANT TO PARAGRAPH (a) OF THIS SUBSECTION (1) MAY ESTABLISH A
7 PROGRAM FOR ITS EMPLOYEES TO PURCHASE DIRECTLY FROM THE
8 WHOLESALER VINOUS OR SPIRITUOUS LIQUORS SOLD BY THAT
9 WHOLESALER.

10 **SECTION 2. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
