A BILL FOR AN ACT

101 **CONCERNING DISTRICT ATTORNEYS REPRESENTATION IN CERTAIN**
102 **HEARINGS ARISING FROM INTERSTATE SUPERVISION COMPACTS.**

Bill Summary

Under the rules of 2 interstate compacts on the supervision of out-of-state offenders, the offender is entitled to a probable cause hearing before the offender is returned to the state in which the offender was sentenced. The bill clarifies that a district attorney shall appear and represent the state at such hearings.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 20-1-102, **amend** (1)
3 introductory portion, (1) (d), and (1) (e); and **add** (1) (f) as follows:

4 **20-1-102. Appear on behalf of state and counties.** (1) Every
5 district attorney shall appear in behalf of the state and the several counties
6 of his OR HER district:

7 (d) In any such indictment, action, or proceeding which may be
8 brought to the district court of any county in his OR HER district by change
9 of venue from any other district; ~~and~~

10 (e) When he OR SHE may deem it advisable to do so, in the
11 preliminary examination of persons charged with any offense before any
12 judge within his OR HER district; AND

13 (f) IN ANY PROBATION PROBABLE CAUSE HEARING BROUGHT
14 PURSUANT TO THE RULES ADOPTED UNDER THE "INTERSTATE COMPACT
15 FOR ADULT OFFENDER SUPERVISION", PART 28 OF ARTICLE 60 OF TITLE 24,
16 C.R.S., OR THE INTERSTATE COMPACT FOR JUVENILES, PART 7 OF ARTICLE
17 60 OF TITLE 24, C.R.S.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
