A BILL FOR AN ACT

101 **CONCERNING THE UNLAWFUL SALE OF CERTAIN PUBLICLY PROVIDED**
102 **GOVERNMENT SERVICES.**

Bill Summary

The bill prohibits a person from reserving or obtaining and selling, intending to sell, bundling in a sale, or selling without obtaining a government service or appointment publicly available without charge. The prohibition does not apply when the person has consent from the government entity or when the person is selling or offering to sell only information. A violation of the prohibition is a class 1 misdemeanor. The

bill also makes a violation a deceptive trade practice, which allows the attorney general and district attorneys to seek civil penalties for a violation.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 18-8-117 as
3 follows:

4 **18-8-117. Unlawful sale of publicly provided services or**
5 **appointments.** (1) A PERSON COMMITS AN UNLAWFUL SALE OF PUBLIC
6 SERVICES IF THE PERSON DOES ANY OF THE FOLLOWING WITH RESPECT TO
7 A GOVERNMENT SERVICE OR AN APPOINTMENT TO RECEIVE A
8 GOVERNMENT SERVICE AND IF A GOVERNMENT ENTITY MAKES THE
9 SERVICE OR APPOINTMENT PUBLICLY AVAILABLE WITHOUT CHARGE:

10 (a) THE PERSON RESERVES OR OBTAINS THE SERVICE OR
11 APPOINTMENT, AND THE PERSON SELLS THE SERVICE OR APPOINTMENT;

12 (b) THE PERSON RESERVES OR OBTAINS, WITH THE INTENT TO SELL,
13 THE SERVICE OR APPOINTMENT;

14 (c) THE PERSON RESERVES OR OBTAINS THE SERVICE OR
15 APPOINTMENT, AND THE PERSON APPENDS THE SERVICE OR APPOINTMENT
16 TO ANOTHER GOOD OR SERVICE THE PERSON OFFERS FOR SALE; OR

17 (d) THE PERSON FALSELY REPRESENTS TO THE POTENTIAL
18 CUSTOMER THAT THE PERSON HAS OBTAINED OR SECURED THE SERVICE OR
19 APPOINTMENT, AND THE PERSON ATTEMPTS TO SELL THE SERVICE OR
20 APPOINTMENT.

21 (2) THIS SECTION DOES NOT APPLY WHEN THE PERSON:

22 (a) HAS CONSENT FROM THE GOVERNMENT ENTITY TO SELL THE
23 SPECIFIC SERVICE OR APPOINTMENT OBTAINED OR RESERVED; OR

24 (b) IS OBTAINING AND SELLING OR OFFERING TO SELL ONLY

1 INFORMATION.

2 (3) UNLAWFUL SALE OF PUBLIC SERVICES IS A CLASS 1
3 MISDEMEANOR, AS DEFINED IN SECTION 18-1.3-501.

4 (4) AS USED IN THIS SECTION, "GOVERNMENT ENTITY" MEANS THE
5 STATE OF COLORADO, A POLITICAL SUBDIVISION OF COLORADO, OR AN
6 AGENCY OF EITHER THE STATE OF COLORADO OR A POLITICAL SUBDIVISION
7 OF COLORADO.

8 **SECTION 2.** In Colorado Revised Statutes, 6-1-105, **add** (1) (iii)
9 as follows:

10 **6-1-105. Deceptive trade practices.** (1) A person engages in a
11 deceptive trade practice when, in the course of the person's business,
12 vocation, or occupation, the person:

13 (iii) VIOLATES SECTION 6-1-726.

14 **SECTION 3.** In Colorado Revised Statutes, **add** 6-1-726 as
15 follows:

16 **6-1-726. Sale of public services.** (1) A PERSON ENGAGES IN A
17 DECEPTIVE TRADE PRACTICE WHEN, IN THE COURSE OF THE PERSON'S
18 BUSINESS, VOCATION, OR OCCUPATION, THE PERSON DOES ANY OF THE
19 FOLLOWING WITH RESPECT TO A GOVERNMENT SERVICE OR AN
20 APPOINTMENT TO RECEIVE A GOVERNMENT SERVICE AND IF A
21 GOVERNMENT ENTITY MAKES THE SERVICE OR APPOINTMENT PUBLICLY
22 AVAILABLE WITHOUT CHARGE:

23 (a) THE PERSON RESERVES OR OBTAINS THE SERVICE OR
24 APPOINTMENT, AND THE PERSON SELLS THE SERVICE OR APPOINTMENT;

25 (b) THE PERSON RESERVES OR OBTAINS, WITH THE INTENT TO SELL,
26 THE SERVICE OR APPOINTMENT;

27 (c) THE PERSON RESERVES OR OBTAINS THE SERVICE OR

1 APPOINTMENT, AND THE PERSON APPENDS THE SERVICE OR APPOINTMENT
2 TO ANOTHER GOOD OR SERVICE THE PERSON OFFERS FOR SALE; OR

3 (d) THE PERSON FALSELY REPRESENTS TO THE POTENTIAL
4 CUSTOMER THAT THE PERSON HAS OBTAINED OR SECURED THE SERVICE OR
5 APPOINTMENT, AND THE PERSON ATTEMPTS TO SELL THE SERVICE OR
6 APPOINTMENT.

7 (2) THIS SECTION DOES NOT APPLY WHEN THE PERSON:

8 (a) HAS CONSENT FROM THE GOVERNMENT ENTITY TO SELL THE
9 SPECIFIC SERVICE OR APPOINTMENT OBTAINED OR RESERVED; OR

10 (b) IS OBTAINING AND SELLING OR OFFERING TO SELL ONLY
11 INFORMATION.

12 (3) AS USED IN THIS SECTION, "GOVERNMENT ENTITY" MEANS THE
13 STATE OF COLORADO, A POLITICAL SUBDIVISION OF COLORADO, OR AN
14 AGENCY OF EITHER THE STATE OF COLORADO OR A POLITICAL SUBDIVISION
15 OF COLORADO.

16 **SECTION 4. Effective date - applicability.** This act takes effect
17 July 1, 2016, and applies to offenses committed on or after said date.

18 **SECTION 5. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
