**A BILL FOR AN ACT**

101 **CONCERNING CONTINUATION OF THE VOLUNTARY CONTRIBUTION TO**  
102 **THE MILITARY FAMILY RELIEF FUND.**

**Bill Summary**

The voluntary contribution program, commonly referred to as the tax check-off program, benefiting the military family relief fund (fund) is scheduled to repeal on January 1, 2017. The bill extends, for 5 years, the period for which the state income tax return forms include a line allowing individual taxpayers to make a voluntary contribution to the fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 39-22-3001  
3 as follows:

4           **39-22-3001. Voluntary contribution designation -**  
5 **procedure.** For income tax years commencing on or after ~~January 1,~~  
6 ~~2011~~ JANUARY 1, 2016, but prior to ~~January 1, 2016~~ JANUARY 1, 2021, the  
7 Colorado state individual income tax return form ~~shall~~ MUST contain a  
8 line whereby each individual taxpayer may designate the amount of the  
9 contribution, if any, the individual wishes to make to the military family  
10 relief fund created in section 28-3-1502, C.R.S.

11           **SECTION 2.** In Colorado Revised Statutes, **amend** 39-22-3003  
12 as follows:

13           **39-22-3003. Repeal of part.** This part 30 is repealed, effective  
14 ~~January 1, 2017~~ JANUARY 1, 2022, unless the voluntary contribution to the  
15 military family relief fund is continued or reestablished by the general  
16 assembly acting by bill prior to said date.

17           **SECTION 3. Act subject to petition - effective date.** This act  
18 takes effect at 12:01 a.m. on the day following the expiration of the  
19 ninety-day period after final adjournment of the general assembly (August  
20 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a  
21 referendum petition is filed pursuant to section 1 (3) of article V of the  
22 state constitution against this act or an item, section, or part of this act  
23 within such period, then the act, item, section, or part will not take effect  
24 unless approved by the people at the general election to be held in  
25 November 2016 and, in such case, will take effect on the date of the  
26 official declaration of the vote thereon by the governor.
