A BILL FOR AN ACT

101 CONCERNING THE AUTHORITY OF THE COMMISSIONER OF  
102 AGRICULTURE TO DISPOSE OF AND ACQUIRE SPECIFIED REAL  
103 PROPERTY IN FURTHERANCE OF THE DEPARTMENT OF  
104 AGRICULTURE'S OFFICE CONSOLIDATION.

Bill Summary

The bill grants the commissioner of agriculture the authority, in consultation with the office of the state architect, to sell the vacated property at 5000 Packing House Road, in Denver, Colorado, which

houses the department of agriculture's warehouse and storage facility. The proceeds of the sale must be credited to the agriculture management fund to be used for the acquisition of real property authorized in the bill subject to appropriation.

The bill grants the commissioner of agriculture the authority, in consultation with the office of the state architect, to acquire the real property located in the Interlocken area at 300 Technology Drive, Broomfield, Colorado, for the future home of the inspection and consumer services division facility. The bill specifies that the construction of the new facility must be subject to the normal capital construction approval process.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby finds and declares that:

4 (a) In 2013, the General Assembly granted the department of  
5 agriculture the authority to enter into lease-purchase agreements for the  
6 acquisition of a department headquarters in Broomfield, Colorado, for the  
7 department of agriculture to consolidate most of the department's  
8 divisions, except for the Colorado state fair;

9 (b) Since the 2013 legislation was enacted, the department of  
10 agriculture has moved into its new headquarters at 305 Interlocken  
11 Parkway, in Broomfield, Colorado. The department still uses property at  
12 5000 Packing House Road, in Denver, Colorado, for the department's  
13 warehouse and storage facility. It is the department of agriculture's  
14 understanding that the City and County of Denver is interested in this real  
15 property for a planned project of the National Western Center partnership.

16 (c) The department has not yet consolidated its current inspection  
17 and consumer services division facility from its location in the Highlands  
18 neighborhood of metro Denver because the lab areas necessary for that  
19 division could not be constructed at the new headquarters division; and

1 (d) The department now seeks approval to sell the property where  
2 the department's warehouse and storage facility is located and use the  
3 proceeds of that sale to help fund the purchase of vacant land behind the  
4 headquarters building in Broomfield, Colorado. It is the department's  
5 future plan to use the vacant land in Broomfield to build a lab area to  
6 house the inspection and consumer services division facility, subject to  
7 the normal capital construction request process.

8 **SECTION 2. Authority for a sale and an acquisition of real**  
9 **property.** (1) The state of Colorado, acting by and through the  
10 Commissioner of Agriculture and in consultation with the office of the  
11 state architect, is authorized to execute a real property sale, at fair market  
12 value, for property held by the department of agriculture at 5000 Packing  
13 House Road, Denver, Colorado. The proceeds of the sale must be credited  
14 to the agriculture management fund as specified in section 35-1-106.9,  
15 Colorado Revised Statutes, and such proceeds must be used to acquire the  
16 property described in subsection (2) of this section, subject to  
17 appropriation.

18 (2) (a) The state of Colorado, acting by and through the  
19 Commissioner of Agriculture and in consultation with the office of the  
20 state architect, is authorized to acquire real property located in the  
21 Interlocken area at 300 Technology Drive, Broomfield, Colorado, parcel  
22 number 157533413004, for the future home of the inspection and  
23 consumer services division facility.

24 (b) Any future capital construction project for a new building to  
25 house the inspection and consumer services division facility must be  
26 prioritized for funding by the office of state planning and budgeting in its  
27 submission to the capital development committee made pursuant to

1 section 24-37-304 (1) (c.3) (I) (C), Colorado Revised Statutes,  
2 recommended for funding by the capital development committee pursuant  
3 to section 2-3-1305, Colorado Revised Statutes, and included in the  
4 governor's annual executive budget proposed to the general assembly  
5 pursuant to section 24-37-301, Colorado Revised Statutes.

6 **SECTION 3.** In Colorado Revised Statutes, **amend** 35-1-106.9  
7 as follows:

8 **35-1-106.9. Agriculture management fund - creation.** There is  
9 hereby created in the state treasury the agriculture management fund. The  
10 fund shall consist of moneys transferred pursuant to section 38-13-116.7  
11 (3), C.R.S., ~~and~~ any moneys realized from the sale of the inspection and  
12 consumer services division facility AND OTHER REAL PROPERTY  
13 ASSOCIATED WITH THAT FACILITY THAT ARE ALL LOCATED IN THE  
14 HIGHLANDS NEIGHBORHOOD OF DENVER, COLORADO, AND ANY MONEYS  
15 REALIZED FROM THE SALE OF THE WAREHOUSE AND STORAGE FACILITY  
16 LOCATED AT 5000 PACKING HOUSE ROAD, DENVER, COLORADO. The  
17 department shall use such moneys to fund agricultural efforts approved  
18 by the commissioner, including, but not limited to, funding additional  
19 department employees necessary to implement and manage approved  
20 programs. Moneys may be used for direct assistance or grant assistance  
21 for conservation districts created pursuant to article 70 of this title.  
22 Moneys in the fund may be used for expenses related to the department's  
23 office consolidation as authorized by House Bill 13-1234, enacted in  
24 2013, AND AS AUTHORIZED BY HOUSE BILL 16-1460, ENACTED IN 2016.  
25 Moneys in the fund are subject to annual appropriation to the department.  
26 Any moneys not expended or encumbered from any appropriation at the  
27 end of any fiscal year shall remain available for expenditure in the next

1 fiscal year without further appropriation. All interest derived from the  
2 deposit and investment of moneys in the fund shall be credited to the fund  
3 and shall not be transferred or credited to the general fund or any other  
4 fund.

5 **SECTION 4. Safety clause.** The general assembly hereby finds,  
6 determines, and declares that this act is necessary for the immediate  
7 preservation of the public peace, health, and safety.
