A BILL FOR AN ACT

101 **CONCERNING THE OPTION FOR CERTAIN PUBLIC SCHOOLS TO CHARGE**
102 **FOR BREAKFAST AFTER THE BELL FOR A STUDENT WHO IS NOT**
103 **ELIGIBLE FOR FREE OR REDUCED-COST LUNCH UNDER THE**
104 **NATIONAL SCHOOL LUNCH PROGRAM.**

Bill Summary

The bill allows a public school that has at least 70% of students, but less than 80% of students, who are eligible for free or reduced-cost lunch under the national school lunch program to charge for breakfast

after the bell for those students who are not eligible for free or reduced-cost lunch. A public school that charges for breakfast after the bell must do so in a way that does not create an apparent distinction between a student who is being charged for breakfast and a student who is receiving a free breakfast.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-82.8-103, **amend**
3 (1) and (3) (b) as follows:

4 **22-82.8-103. Breakfast after the bell nutrition program -**
5 **creation - objectives - requirements - administration.** (1) There is
6 hereby created the breakfast after the bell nutrition program. The purpose
7 of the program is to offer ~~a free~~ breakfast AFTER THE BELL to each student
8 enrolled in a public school that has seventy percent or more students who
9 are eligible for free or reduced-cost lunch under the school lunch
10 program.

11 (3) (b) (I) ~~Beginning in~~ FOR the 2015-2016 school year ~~and each~~
12 ~~year thereafter~~, except as provided for in this subsection (3) and
13 subsection (4) of this section, each public school in the state that has AT
14 LEAST seventy percent or more students, BUT LESS THAN EIGHTY PERCENT
15 OF STUDENTS, who are eligible for free or reduced-cost lunch under the
16 school lunch program in the prior school year shall offer a free breakfast
17 to each student in the school.

18 (II) BEGINNING IN THE 2016-17 SCHOOL YEAR, EACH PUBLIC
19 SCHOOL THAT HAS AT LEAST SEVENTY PERCENT OR MORE STUDENTS, BUT
20 LESS THAN EIGHTY PERCENT OF STUDENTS, WHO ARE ELIGIBLE FOR FREE
21 OR REDUCED-COST LUNCH UNDER THE SCHOOL LUNCH PROGRAM IN THE
22 PRIOR SCHOOL YEAR SHALL OFFER FREE BREAKFAST TO EACH STUDENT IN
23 THE SCHOOL; EXCEPT THAT THE SCHOOL MAY CHARGE A STUDENT FOR

1 BREAKFAST WHO IS NOT ELIGIBLE FOR FREE OR REDUCED-COST LUNCH, SO
2 LONG AS THE METHOD FOR CHARGING THE STUDENT DOES NOT CREATE AN
3 APPARENT DISTINCTION BETWEEN A STUDENT WHO IS BEING CHARGED FOR
4 BREAKFAST AND A STUDENT WHO IS RECEIVING A FREE BREAKFAST.

5 (III) If a public school falls below the seventy percent threshold
6 for two consecutive years, it has the option to continue participating in the
7 program but is not required to do so. A public school or charter school
8 that does not participate in the school lunch program is not required to
9 participate.

10 **SECTION 2. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
