HB16-1047 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend the Health, Insurance and Environment Committee Report, dated  
2 February 4, 2016, page 1, after line 2 insert:

3           **""24-60-3603. Effective date of part.** THIS PART 36 TAKES EFFECT  
4 ON JANUARY 1, 2017, OR THE DATE ON WHICH THE INTERSTATE MEDICAL  
5 LICENSURE COMPACT COMMISSION CREATED IN SECTION 11 OF SECTION  
6 24-60-3602 IS ABLE TO FULLY IMPLEMENT THE INTERSTATE MEDICAL  
7 LICENSURE COMPACT AND LICENSES ARE ABLE TO BE ISSUED THROUGH THE  
8 PROCESS SPECIFIED IN THE COMPACT, WHICHEVER IS LATER. THE  
9 EXECUTIVE DIRECTOR OF THE DEPARTMENT OF REGULATORY AGENCIES  
10 SHALL NOTIFY THE REVISOR OF STATUTES, IN WRITING, WHEN THE  
11 CONDITIONS SPECIFIED IN THIS SECTION OCCUR."

12 Page 1 of the committee report, line 3, strike **""SECTION"** and substitute  
13 **"SECTION"**.

14 Page 2 of the committee report, line 7, strike **"TITLE;".** and substitute  
15 **"TITLE;**

16           **SECTION 4.** In Colorado Revised Statutes, 24-34-101, **add** (14)  
17 as follows:

18           **24-34-101. Department created - executive director.** (14) FOR  
19 PURPOSES OF THE INTERSTATE MEDICAL LICENSURE COMPACT ENACTED IN  
20 PART 36 OF ARTICLE 60 OF THIS TITLE, THE EXECUTIVE DIRECTOR SHALL

1 APPOINT TWO INDIVIDUALS SATISFYING THE CRITERIA SET FORTH IN  
2 SECTION 11 (d) OF THE COMPACT TO REPRESENT THE STATE ON THE  
3 INTERSTATE MEDICAL LICENSURE COMPACT COMMISSION CREATED IN  
4 SECTION 11 OF THE COMPACT. UPON APPOINTMENT, THE INDIVIDUALS  
5 APPOINTED TO THE COMMISSION UNDER THIS SUBSECTION (14) SHALL  
6 PARTICIPATE IN COMMISSION MEETINGS AND ACTIVITIES."."
