After consideration on the merits, the Committee recommends the following:

HB16-1195 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 3, line 3, strike "25.5-6-303 (13)." and substitute  
2 "25.5-6-303".

3 Page 3, after line 15 insert:

4 "SECTION 5. In Colorado Revised Statutes, 25.5-6-603, **add** (2)  
5 as follows:

6 **25.5-6-603. Definitions.** As used in this part 6, unless the context  
7 otherwise requires:

8 (2) "HOME MODIFICATION SERVICES" HAS THE SAME MEANING AS  
9 SET FORTH IN SECTION 25.5-6-303.

10 **SECTION 6.** In Colorado Revised Statutes, 25.5-6-606, **amend**  
11 (1) as follows:

12 **25.5-6-606. Implementation of program for mentally ill**  
13 **authorized - federal waiver - duties of the department of health care**  
14 **policy and financing and the department of human services.** (1) The  
15 state department is hereby authorized to seek any necessary waiver from  
16 the federal government to develop and implement a home- and  
17 community-based services program for persons with major mental  
18 illnesses. The program shall be designed to provide home- and  
19 community-based services to eligible persons. Eligibility may be limited  
20 to persons who meet the level of services provided in a nursing facility,  
21 and services for eligible persons may be established in state board rules

1 to the extent such eligibility criteria and services are authorized or  
2 required by federal waiver. The program shall include services provided  
3 under the consumer-directed care service model, part 11 of this article.  
4 THE PROGRAM SHALL ALSO INCLUDE HOME MODIFICATION SERVICES.  
5 SUBJECT TO FEDERAL AUTHORIZATION, THE INDIVIDUAL CAP ON THE  
6 AMOUNT OF HOME MODIFICATION SERVICES THAT AN ELIGIBLE PERSON  
7 MAY RECEIVE RESETS UPON EACH RENEWAL OF THE WAIVER AUTHORIZING  
8 THE SERVICES PROVIDED PURSUANT TO THIS PART 6.

9 **SECTION 7.** In Colorado Revised Statutes, 25.5-6-1302, **add**  
10 (2.5) as follows:

11 **25.5-6-1302. Definitions.** As used in this part 13, unless the  
12 context otherwise requires:

13 (2.5) "HOME MODIFICATION SERVICES" HAS THE SAME MEANING AS  
14 SET FORTH IN SECTION 25.5-6-303.

15 **SECTION 8.** In Colorado Revised Statutes, 25.5-6-1303, **add**  
16 (6.5) as follows:

17 **25.5-6-1303. Pilot program - complementary or alternative**  
18 **medicine - rules.** (6.5) IN ADDITION TO ANY OTHER SERVICES PROVIDED  
19 PURSUANT TO THIS PART 13, THE PILOT PROGRAM SHALL ALSO INCLUDE  
20 HOME MODIFICATION SERVICES. SUBJECT TO FEDERAL AUTHORIZATION,  
21 THE INDIVIDUAL CAP ON THE AMOUNT OF HOME MODIFICATION SERVICES  
22 THAT AN ELIGIBLE PERSON WITH A DISABILITY MAY RECEIVE RESETS UPON  
23 EACH RENEWAL OF THE WAIVER AUTHORIZING THE SERVICES PURSUANT TO  
24 THIS PART 13."
