After consideration on the merits, the Committee recommends the following:

HB16-1301 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 2 substitute "residencies, pre-apprenticeships, and".
- 3 Page 2, strike lines 19 and 20.
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 3, strike line 8.
- 6 Page 3, line 11, strike "LABOR." and substitute "LABOR; AND".
- 7 Page 3, before line 12 insert:
- 8 "(III) MEETS THE "QUALITY PRE-APPRENTICESHIP PROGRAM"
- 9 STANDARDS MAINTAINED BY THE EMPLOYMENT AND TRAINING
- 10 ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF LABOR."
- 11 Page 3, strike lines 19 through 27.
- 12 Page 4, strike lines 1 through 3.
- 13 Page 4, after line 6 insert:
- 14 "(g) "RESIDENCY PROGRAM" MEANS A PROGRAM DEFINED BY THE
- 15 WORK FORCE DEVELOPMENT COUNCIL OR THE DEPARTMENT OF LABOR AND

1 EMPLOYMENT THAT:
2 (I) PROVIDES INDIVIDUALS WITH A SET OF WELL-DEFINED
3 OCCUPATIONAL SKILLS AND ABILITIES BY TEACHING BOTH THEORETICAL
4 AND PRACTICAL CONCEPTS PRIMARILY THROUGH ON-THE-JOB TRAINING
5 AND RELATED INSTRUCTION; AND
6 (II) ENSURES THE INDIVIDUAL RECEIVES A FORM OF
7 COMPENSATION FOR SUCH ON-THE-JOB TRAINING."

8 Reletter succeeding paragraphs accordingly.

19 APPRENTICESHIP PROGRAM WHO IS".

20 Page 7, strike lines 3 through 5 and substitute "IDENTIFICATION OF THE
21 SELECTED RESIDENT, APPRENTICE, OR INDIVIDUAL IN A CONSTRUCTION
22 INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION
23 INDUSTRY APPRENTICESHIP PROGRAM, AND THE ACTUAL OR ANTICIPATED
24 START DATE OF THE SELECTED RESIDENT, APPRENTICE, OR INDIVIDUAL IN
25 A CONSTRUCTION INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A
26 CONSTRUCTION INDUSTRY APPRENTICESHIP PROGRAM."

27 Page 7, lines 24 and 25, strike "PRE-APPRENTICE OR APPRENTICE" and
28 substitute "RESIDENT, APPRENTICE, OR INDIVIDUAL IN A CONSTRUCTION
29 INDUSTRY PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION
30 INDUSTRY APPRENTICESHIP PROGRAM".

1 Page 7, lines 25 and 26, strike "RETAINED FOR THE CREDIT PERIOD," and
2 substitute "RETAINED,".

3 Page 8, line 15, strike "PRE-APPRENTICE" and substitute "RESIDENT OR
4 INDIVIDUAL IN A CONSTRUCTION INDUSTRY PRE-APPRENTICESHIP
5 PROGRAM".

6 Page 8, line 17, strike "APPRENTICE." and substitute "APPRENTICE OR
7 INDIVIDUAL IN A CONSTRUCTION INDUSTRY APPRENTICESHIP PROGRAM.".

8 Page 8, strike lines 21 and 22 and substitute "THE NUMBER OF RESIDENTS,
9 APPRENTICES, OR INDIVIDUALS IN A CONSTRUCTION INDUSTRY
10 PRE-APPRENTICESHIP PROGRAM OR IN A CONSTRUCTION INDUSTRY
11 APPRENTICESHIP PROGRAM THAT EACH QUALIFIED TAXPAYER RETAINS.".
