A BILL FOR AN ACT

101 CONCERNING HUMAN TRAFFICKING FOR SEXUAL SERVITUDE.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov/.)

The bill amends the language defining the crime of human trafficking for sexual servitude to include "purchasing" another person or a minor for the purpose of coercing the person or minor to engage in commercial sexual activity. Current law requires a person convicted of human trafficking of a minor for sexual servitude to be placed on the Colorado sex offender registry; the bill extends that requirement to persons convicted of human trafficking of any person of any age.

2	SECTION 1. In Colorado Revised Statutes, 18-3-502, add (11.5)

13	SECTION 2. In Colorado Revised Statutes, 18-3-504, amend
14	(2)(a); and add (2.5) as follows:
15	18-3-504. Human trafficking for sexual servitude - human
16	trafficking of a minor for sexual servitude. (2) (a) (I) A person who
17	knowingly sells, recruits, harbors, transports, transfers, isolates, entices,
18	provides, receives, obtains by any means, maintains, or makes available
19	a minor for the purpose of commercial sexual activity commits human
20	trafficking of a minor for sexual servitude.
21	(II) A PERSON WHO KNOWINGLY ADVERTISES, OFFERS TO SELL, OR
22	SELLS TRAVEL SERVICES THAT FACILITATE AN ACTIVITY PROHIBITED
23	PURSUANT TO SUBSECTION (2)(a)(I) OF THIS SECTION COMMITS HUMAN
24	TRAFFICKING OF A MINOR FOR SEXUAL SERVITUDE.
25	(2.5) It is an affirmative defense to a charge pursuant to

1	THE PERSON'S SENTENCE AND HIS OR HER DISCHARGE FROM THE
2	DEPARTMENT OF CORRECTIONS, IF HE OR SHE WAS SENTENCED TO
3	INCARCERATION, OR DISCHARGE FROM THE DEPARTMENT OF HUMAN
4	SERVICES, IF HE OR SHE WAS COMMITTED TO SUCH DEPARTMENT, OR FINAL

22	SECTION 5. Effective date - applicability. This act takes effect
23	September 1, 2017, and applies to offenses committed on or after said
24	date.
25	SECTION 6. Safety clause. The general assembly hereby finds,
26	determines, and declares that this act is necessary for the immediate
27	preservation of the public peace, health, and safety.
