A BILL FOR AN ACT

101 CONCERNING THE REPEAL OF THE COLORADO FAMILY SUPPORT LOAN  
102 PROGRAM, AND, IN CONNECTION THEREWITH, TRANSFERRING  
103 FUNDS FROM THE COLORADO FAMILY SUPPORT LOAN PROGRAM  
104 TO THE FAMILY SUPPORT SERVICES PROGRAM TO PROVIDE  
105 SERVICES FOR FAMILIES OF PERSONS WITH INTELLECTUAL AND  
106 DEVELOPMENTAL DISABILITIES.

The new family support services fund may be used for expenses relating to the termination and wind up of the Colorado family support loan fund, and to provide services under the family support services program to support families caring for a family member with intellectual and developmental disabilities.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **repeal** 25.5-10-401  
3 and 25.5-10-403.

4           **SECTION 2.** In Colorado Revised Statutes, 25.5-10-402, **add** (6)  
5 as follows:

6           **25.5-10-402. Colorado family support loan fund - creation -**  
7 **loans to families - repeal.** (6) (a) THIS SECTION IS REPEALED, EFFECTIVE  
8 JULY 1, 2017.

9           (b) PRIOR TO ITS REPEAL, THE STATE TREASURER SHALL TRANSFER  
10 ANY MONEY REMAINING IN THE FUND TO THE FAMILY SUPPORT SERVICES  
11 FUND CREATED IN SECTION 25.5-10-305.5.

12           **SECTION 3.** In Colorado Revised Statutes, **add** 25.5-10-305.5  
13 as follows:

14           **25.5-10-305.5. Family support services fund - creation.**

15 (1) THE FAMILY SUPPORT SERVICES FUND, REFERRED TO IN THIS SECTION  
16 AS THE "FUND", IS HEREBY CREATED IN THE STATE TREASURY. THE FUND  
17 CONSISTS OF MONEY TRANSFERRED TO THE FUND FROM THE COLORADO  
18 FAMILY SUPPORT LOAN FUND AS CREATED IN SECTION 25.5-10-402 PRIOR  
19 TO ITS REPEAL, PAYMENTS RELATING TO OUTSTANDING LOANS MADE FROM  
20 THE COLORADO FAMILY SUPPORT LOAN FUND AS CREATED IN SECTION  
21 25.5-10-402 PRIOR TO ITS REPEAL, AND ANY OTHER MONEY THAT THE  
22 GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE FUND.

1           (2) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND  
2 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE  
3 FUND TO THE FUND.

4           (3) SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL  
5 ASSEMBLY, THE STATE DEPARTMENT MAY EXPEND MONEY FROM THE FUND  
6 FOR NECESSARY EXPENDITURES RELATING TO THE ADMINISTRATION OF  
7 OUTSTANDING LOANS MADE FROM THE COLORADO FAMILY SUPPORT LOAN  
8 FUND AS CREATED IN SECTION 25.5-10-402 PRIOR TO ITS REPEAL, AND TO  
9 PROVIDE FAMILY SUPPORT SERVICES PURSUANT TO THIS PART 3.

10           **SECTION 4.** In Colorado Revised Statutes, 25.5-10-303, **add** (5)  
11 as follows:

12           **25.5-10-303. Administration - duties of department.** (5) THE  
13 STATE DEPARTMENT SHALL TAKE ANY NECESSARY ACTIONS RELATING TO  
14 THE TERMINATION AND WIND UP OF THE COLORADO FAMILY SUPPORT  
15 LOAN FUND AS CREATED IN SECTION 25.5-10-402 PRIOR TO ITS REPEAL.  
16 THE STATE DEPARTMENT SHALL RECEIVE PAYMENTS RELATING TO  
17 OUTSTANDING LOANS MADE FROM THE COLORADO FAMILY SUPPORT LOAN  
18 FUND AS CREATED IN SECTION 25.5-10-402 PRIOR TO ITS REPEAL, WHICH  
19 PAYMENTS SHALL BE TRANSFERRED TO THE STATE TREASURER AND  
20 CREDITED TO THE FAMILY SUPPORT SERVICES FUND CREATED IN SECTION  
21 25.5-10-303.5.

22           **SECTION 5. Effective date.** This act takes effect July 1, 2017.

23           **SECTION 6. Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, and safety.
