A BILL FOR AN ACT

101 **CONCERNING THE USE OF OPEN EDUCATIONAL RESOURCES IN PUBLIC**
102 **INSTITUTIONS OF HIGHER EDUCATION, AND, IN CONNECTION**
103 **THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

Joint Budget Committee. The bill creates the open educational resources council (council) in the department of higher education (department). The council includes persons appointed by the executive director of the department from public institutions of higher education, the executive director of the department, the commissioner of education,

and the state librarian.

The bill directs the department to contract with an entity to evaluate the existing use of open educational resources by public institutions of higher education. The council must facilitate the work of the contracting entity, and, taking into account the findings of the contracting entity, recommend initiatives to expand the use of open educational resources. The council must report the findings of the contracting entity and its recommended initiatives to the joint budget committee and the education committees of the general assembly by November 20, 2017.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, **add** 23-1-134 as follows:

23-1-134. Department directive - open educational resource initiatives - council created - report - definitions - legislative declaration - repeal. (1) THE GENERAL ASSEMBLY FINDS THAT THE COSTS OF TEXTBOOKS AND INSTRUCTIONAL MATERIALS HAVE RISEN TO EXORBITANT LEVELS, INCREASING THE COSTS FOR A FIRST-YEAR STUDENT ENROLLED IN A COMMUNITY COLLEGE BY AS MUCH AS TWENTY-TWO PERCENT ABOVE THE STUDENT'S TUITION AND FEES. BECAUSE OF THE HIGH PRICE OF TEXTBOOKS, SOME STUDENTS, ESPECIALLY LOW-INCOME STUDENTS, DO NOT BUY THE TEXTBOOKS REQUIRED FOR A COURSE, RESULTING IN SIGNIFICANT NEGATIVE EDUCATIONAL IMPACTS, INCLUDING IN SOME CASES FAILING THE COURSE. STUDENTS MAY ALSO CHOOSE TO WITHDRAW FROM A COURSE BECAUSE OF THE HIGH COST OF THE TEXTBOOKS THAT THE COURSE REQUIRES. SEVERAL INSTITUTIONS OF HIGHER EDUCATION ACROSS THE COUNTRY HAVE BEGUN PARTICIPATING IN OPEN EDUCATIONAL RESOURCES CONSORTIA THAT MAKE TEXTBOOKS, SYLLABI, COURSE ACTIVITIES, AND READINGS AVAILABLE TO STUDENTS ONLINE FOR NO COST, RESULTING IN SIGNIFICANT STUDENT SAVINGS. IT IS

1 APPROPRIATE TO CONSIDER INITIATIVES TO INCREASE THE USE OF OPEN
2 EDUCATIONAL RESOURCES IN PUBLIC INSTITUTIONS OF HIGHER EDUCATION
3 TO PROVIDE COST SAVINGS AND OTHER EDUCATIONAL BENEFITS FOR
4 STUDENTS ENROLLED IN PUBLIC INSTITUTIONS OF HIGHER EDUCATION,
5 INCLUDING THOSE STUDENTS WHO ARE CONCURRENTLY ENROLLED IN HIGH
6 SCHOOL AND POSTSECONDARY COURSES.

7 (2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
8 REQUIRES:

9 (a) "COUNCIL" MEANS THE OPEN EDUCATIONAL RESOURCES
10 COUNCIL CREATED IN SUBSECTION (3) OF THIS SECTION.

11 (b) "OPEN EDUCATIONAL RESOURCES" MEANS HIGH-QUALITY
12 TEACHING, LEARNING, AND RESEARCH RESOURCES THAT RESIDE IN THE
13 PUBLIC DOMAIN OR HAVE BEEN RELEASED UNDER AN INTELLECTUAL
14 PROPERTY LICENSE THAT PERMITS FREE USE OR REPURPOSING BY OTHERS
15 AND MAY INCLUDE OTHER RESOURCES THAT ARE LEGALLY AVAILABLE
16 AND AVAILABLE TO STUDENTS FOR FREE OR VERY LOW COST. OPEN
17 EDUCATIONAL RESOURCES MAY INCLUDE FULL COURSES, COURSE
18 MATERIALS, MODULES, TEXTBOOKS, FACULTY-CREATED CONTENT,
19 STREAMING VIDEOS, TESTS, SOFTWARE, AND OTHER TOOLS, MATERIALS, OR
20 TECHNIQUES USED TO SUPPORT ACCESS TO KNOWLEDGE.

21 (c) "PUBLIC INSTITUTION OF HIGHER EDUCATION" MEANS THE
22 STATE INSTITUTIONS OF HIGHER EDUCATION, AS DEFINED IN SECTION
23 23-18-102 (10)(a), THE LOCAL DISTRICT COLLEGES, AND THE AREA
24 TECHNICAL COLLEGES.

25 (3) (a) THERE IS CREATED IN THE DEPARTMENT OF HIGHER
26 EDUCATION THE OPEN EDUCATIONAL RESOURCES COUNCIL, WHICH IS
27 COMPRISED OF THE FOLLOWING MEMBERS:

1 (I) TEN PERSONS FROM PUBLIC INSTITUTIONS OF HIGHER
2 EDUCATION APPOINTED BY THE EXECUTIVE DIRECTOR AS FOLLOWS:

3 (A) FOUR FACULTY MEMBERS;

4 (B) THREE LIBRARY PROFESSIONALS;

5 (C) ONE INSTRUCTIONAL DESIGN EXPERT;

6 (D) ONE INFORMATIONAL TECHNOLOGY EXPERT; AND

7 (E) ONE ADMINISTRATOR;

8 (II) THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF HIGHER
9 EDUCATION OR HIS OR HER DESIGNEE;

10 (III) THE COMMISSIONER OF EDUCATION APPOINTED PURSUANT TO
11 SECTION 1 (2) OF ARTICLE IX OF THE STATE CONSTITUTION, OR HIS OR HER
12 DESIGNEE; AND

13 (IV) THE PERSON EXECUTING THE DUTIES OF THE STATE
14 LIBRARIAN, IF DIFFERENT FROM THE COMMISSIONER OF EDUCATION AS
15 PROVIDED IN SECTION 24-90-104, OR HIS OR HER DESIGNEE.

16 (b) THE EXECUTIVE DIRECTOR SHALL APPOINT THE MEMBERS OF
17 THE COUNCIL BY JULY 1, 2017. IN APPOINTING THE MEMBERS OF THE
18 COUNCIL, THE EXECUTIVE DIRECTOR SHALL ENSURE THAT THE COUNCIL
19 INCLUDES AT LEAST THREE REPRESENTATIVES FROM TWO-YEAR PUBLIC
20 INSTITUTIONS OF HIGHER EDUCATION AND AT LEAST THREE
21 REPRESENTATIVES FROM FOUR-YEAR PUBLIC INSTITUTIONS OF HIGHER
22 EDUCATION, INCLUDING RESEARCH UNIVERSITIES. TO THE EXTENT
23 PRACTICABLE, THE EXECUTIVE DIRECTOR SHALL APPOINT PERSONS FROM
24 AREAS THROUGHOUT THE STATE WHO ARE REPRESENTATIVE OF THE
25 DEMOGRAPHICS OF THE STATE.

26 (c) THE EXECUTIVE DIRECTOR SHALL CONVENE THE FIRST MEETING
27 OF THE COUNCIL NO LATER THAN JULY 15, 2017. AT THE FIRST MEETING,

1 THE COUNCIL MEMBERS SHALL SELECT A MEMBER TO SERVE AS CHAIR OF
2 THE COUNCIL AND A MEMBER TO SERVE AS VICE-CHAIR OF THE COUNCIL.
3 THE COUNCIL SHALL MEET AS OFTEN AS NECESSARY AT THE CALL OF THE
4 CHAIR TO COMPLETE ITS DUTIES.

5 (d) THE MEMBERS OF THE COUNCIL SERVE WITHOUT
6 COMPENSATION BUT MAY BE REIMBURSED FOR REASONABLE AND
7 NECESSARY EXPENSES INCURRED IN SERVING ON THE COUNCIL, AS
8 DETERMINED BY THE DEPARTMENT.

9 (4) THE COUNCIL SHALL:

10 (a) WORK WITH THE ENTITY WITH WHICH THE DEPARTMENT
11 CONTRACTS AS PROVIDED IN SUBSECTION (6) OF THIS SECTION TO REVIEW
12 AND EVALUATE THE EXTENT TO WHICH EACH PUBLIC INSTITUTION OF
13 HIGHER EDUCATION IS USING OPEN EDUCATIONAL RESOURCES AND
14 OPTIONS FOR AND OBSTACLES TO INCREASING THE USE OF OPEN
15 EDUCATIONAL RESOURCES IN PUBLIC INSTITUTIONS OF HIGHER EDUCATION.
16 THE COUNCIL SHALL ENSURE THAT THE EVALUATION IS COMPLETED NO
17 LATER THAN OCTOBER 20, 2017.

18 (b) SOLICIT INPUT CONCERNING THE USE OF OPEN EDUCATIONAL
19 RESOURCES FROM, AT A MINIMUM, SCHOOL DISTRICTS, CHARTER SCHOOLS,
20 ANY PUBLIC INSTITUTIONS OF HIGHER EDUCATION THAT DO NOT HAVE A
21 REPRESENTATIVE ON THE COUNCIL, AND STUDENTS ENROLLED IN PUBLIC
22 INSTITUTIONS OF HIGHER EDUCATION;

23 (c) BASED ON THE RESULTS OF THE EVALUATION, RECOMMEND
24 INITIATIVES FOR INCREASING THE USE OF OPEN EDUCATIONAL RESOURCES
25 THAT ARE LIKELY TO RESULT IN COST SAVINGS AND OTHER EDUCATIONAL
26 BENEFITS FOR STUDENTS ENROLLED IN PUBLIC INSTITUTIONS OF HIGHER
27 EDUCATION, INCLUDING STUDENTS WHO ARE CONCURRENTLY ENROLLED

1 IN HIGH SCHOOL AND POSTSECONDARY COURSES AS PROVIDED IN ARTICLE
2 35 OF TITLE 22. THE COUNCIL SHALL EXAMINE A RANGE OF INITIATIVES
3 AND CONSIDER THE EFFECTIVENESS OF INITIATIVES IMPLEMENTED IN
4 OTHER STATES. THE RECOMMENDED INITIATIVES MAY INCLUDE BUT ARE
5 NOT LIMITED TO:

6 (I) IDENTIFYING OPEN EDUCATIONAL RESOURCE MATERIALS THAT
7 ARE ASSOCIATED WITH THE CORE GENERAL EDUCATION COURSES
8 IDENTIFIED PURSUANT TO SECTION 23-1-125 (3) AND THE CORE
9 COMPETENCIES IDENTIFIED FOR CAREER AND TECHNICAL EDUCATION
10 CREDENTIALS AND DETERMINING THE BEST MECHANISM TO ASSIST
11 FACULTY AND STUDENTS IN IDENTIFYING, ACCESSING, AND USING THESE
12 MATERIALS. IN CONSIDERING THESE ISSUES, THE COUNCIL MAY INCLUDE
13 RECOMMENDATIONS CONCERNING METHODS FOR ENSURING THAT
14 IDENTIFIED MATERIALS ARE OF HIGH QUALITY, ARE LEGALLY AVAILABLE
15 FOR USE, AND REMAIN CURRENT.

16 (II) DEVELOPING RECOMMENDATIONS FOR A GRANT PROGRAM TO
17 PROMOTE ADOPTION AND USE OF OPEN EDUCATIONAL RESOURCES ON A
18 REGIONAL OR STATEWIDE BASIS. THE GRANT PROGRAM MAY PROVIDE
19 FUNDING FOR, BUT NEED NOT BE LIMITED TO, THE FOLLOWING:

20 (A) STAFF DEVELOPMENT AND TRAINING AND TECHNOLOGY
21 SUPPORT;

22 (B) FACULTY INCENTIVES TIED TO IMPLEMENTATION AND USE OF
23 OPEN EDUCATIONAL RESOURCES;

24 (C) EFFORTS TO CREATE AND BRAND ENTIRE COURSES OR
25 SECTIONS OF COURSES AS FREE-MATERIAL, OPEN-EDUCATIONAL-RESOURCE
26 COURSES; AND

27 (D) INCENTIVES AND SUPPORT FOR LIBRARIES AT PUBLIC

1 INSTITUTIONS OF HIGHER EDUCATION OR LIBRARIES IN CONCURRENT
2 ENROLLMENT SITES TO IMPROVE THE EXISTING INFRASTRUCTURE IN
3 LIBRARIES FOR STORING, ACCESSING, AND SHARING LEARNING MATERIALS
4 AMONG STUDENTS, FACULTY, AND INSTITUTIONS; AND

5 (III) IDENTIFYING STRATEGIES TO LEVERAGE THE OPEN
6 EDUCATIONAL RESOURCE WORK AND KNOWLEDGE AT ONE PUBLIC
7 INSTITUTION OF HIGHER EDUCATION INTO A KNOWLEDGE BASE FOR OTHER
8 INSTITUTIONS, WHICH MAY INCLUDE ACTIVE SHARING OF MATERIALS,
9 METHODS, AND TECHNOLOGY PLATFORMS; MARKETING OF THE OPEN
10 EDUCATIONAL RESOURCES; PROFESSIONAL DEVELOPMENT FOR FACULTY
11 AND TRAINING FOR STUDENTS IN THE USE OF OPEN EDUCATIONAL
12 RESOURCES; AND CONFERENCES PROMOTING THE CREATION AND USE OF
13 OPEN EDUCATIONAL RESOURCES.

14 (5) IN RECOMMENDING INITIATIVES, THE COUNCIL SHALL INCLUDE
15 METHODS FOR EVALUATING THE SUCCESS OF EACH RECOMMENDED
16 INITIATIVE, INCLUDING PROCEDURES FOR EVALUATING COST SAVINGS TO
17 STUDENTS BASED ON THE USE OF OPEN EDUCATIONAL RESOURCE
18 MATERIALS IN COURSES AND SECTIONS. THE EVALUATION MAY INCLUDE
19 OTHER COMPONENTS SUCH AS ASSESSING THE EFFECTIVENESS OF PROGRAM
20 PROCESSES AND MATERIALS AND ASSESSING FACULTY AND STUDENT
21 AWARENESS OF THE INITIATIVE.

22 (6) BY AUGUST 1, 2017, THE DEPARTMENT, IN ACCORDANCE WITH
23 THE APPLICABLE PROVISIONS OF THE "PROCUREMENT CODE", ARTICLES
24 101 TO 112 OF TITLE 24, SHALL CONTRACT WITH AN ENTITY TO REVIEW
25 AND EVALUATE THE EXTENT TO WHICH EACH PUBLIC INSTITUTION OF
26 HIGHER EDUCATION IS USING OPEN EDUCATIONAL RESOURCES AND
27 OPTIONS FOR AND OBSTACLES TO INCREASING THE USE OF OPEN

1 EDUCATIONAL RESOURCES IN PUBLIC INSTITUTIONS OF HIGHER EDUCATION.
2 THE ENTITY SHALL COMPLETE THE REVIEW AND SUBMIT A REPORT TO THE
3 COUNCIL AND THE DEPARTMENT BY OCTOBER 20, 2017.

4 (7) THE COUNCIL SHALL PREPARE A REPORT THAT INCLUDES THE
5 REPORT PREPARED PURSUANT TO SUBSECTION (6) OF THIS SECTION AND
6 THE COUNCIL'S RECOMMENDED INITIATIVES FOR SUPPORTING AND
7 EXPANDING THE USE OF OPEN EDUCATIONAL RESOURCES IN COLORADO.
8 THE COUNCIL SHALL SUBMIT THE REPORT BY NOVEMBER 20, 2017, TO THE
9 JOINT BUDGET COMMITTEE OF THE GENERAL ASSEMBLY AND THE
10 EDUCATION COMMITTEES OF THE SENATE AND THE HOUSE OF
11 REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES.

12 (8) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2018.

13 **SECTION 2. Appropriation.** For the 2017-18 state fiscal year,
14 \$25,000 is appropriated to the department of higher education. This
15 appropriation is from the general fund. To implement this act, the
16 department may use this appropriation for the open educational resources
17 council and to contract with an entity to study the use of open educational
18 resources at public institutions of higher education.

19 **SECTION 3. Safety clause.** The general assembly hereby finds,
20 determines, and declares that this act is necessary for the immediate
21 preservation of the public peace, health, and safety.
