101 **CONCERNING CAPITAL-RELATED TRANSFERS OF MONEY.**

**Joint Budget Committee.** For the 2017-18 fiscal year, the bill transfers:

- ! \$68,840,446 from the general fund to the capital construction fund;
- ! \$19,855,515 from the general fund to the information technology capital account of the capital construction fund;
- ! \$500,000 from the general fund exempt account of the general fund to the capital construction fund;

- ! \$20 million from the general fund to the controlled maintenance trust fund; and
- ! \$1 million from the preservation grant program account of the state historical fund to the capital construction fund for historical renovations of the state house of representatives' chambers and the state senate's chambers.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-75-302, **amend**  
3 (2) introductory portion, (2)(cc), (2)(dd), (2.3), (2.5) introductory portion,  
4 (2.5)(j), and (2.5)(k); and **add** (2)(ee) and (2.5)(l) as follows:

5           **24-75-302. Capital construction fund - capital assessment fees**  
6 **- calculation - information technology capital account.** (2) The  
7 controller shall transfer a sum as specified in this subsection (2) from the  
8 general fund to the capital construction fund as ~~moneys become~~ MONEY  
9 BECOMES available in the general fund during the fiscal year beginning on  
10 July 1 of the fiscal year in which the transfer is made. Transfers between  
11 funds pursuant to this subsection (2) are not appropriations subject to the  
12 limitations of section 24-75-201.1. The amounts transferred pursuant to  
13 this subsection (2) are as follows:

14           (cc) On July 1, 2015, one hundred forty-three million nine  
15 hundred fifty-one thousand six hundred thirty-nine dollars; ~~and~~

16           (dd) On July 1, 2016, twenty million five hundred eighty-six  
17 thousand three hundred ninety-eight dollars; AND

18           (ee) ON JULY 1, 2017, SIXTY-EIGHT MILLION EIGHT HUNDRED  
19 FORTY THOUSAND FOUR HUNDRED FORTY-SIX DOLLARS.

20           (2.3) In addition to the sums transferred pursuant to subsections  
21 (2) and (2.5) of this section, the state treasurer and the controller shall  
22 transfer a sum as specified in this subsection (2.3) from the general fund

1 to the information technology capital account created in subsection (3.7)  
2 of this section, as enacted by House Bill 15-1266, as ~~moneys become~~  
3 MONEY BECOMES available in the general fund during the fiscal year  
4 beginning on July 1 of the fiscal year in which the transfer is made.  
5 Transfers between funds pursuant to this subsection (2.3) are not  
6 appropriations subject to the limitations of section 24-75-201.1. The  
7 amounts transferred pursuant to this subsection (2.3) are as follows:

8 (a) On July 1, 2015, seventy-six million eight hundred  
9 seventy-seven thousand seven hundred ninety dollars; ~~and~~

10 (b) On July 1, 2016, ten million six hundred ninety-seven  
11 thousand four hundred nine dollars; AND

12 (c) ON JULY 1, 2017, NINETEEN MILLION EIGHT HUNDRED  
13 FIFTY-FIVE THOUSAND FIVE HUNDRED FIFTEEN DOLLARS.

14 (2.5) In addition to the sums transferred pursuant to subsections  
15 (2) and (2.3) of this section, the state treasurer and the controller shall  
16 transfer a sum as specified in this subsection (2.5) from the general fund  
17 exempt account of the general fund created pursuant to section  
18 24-77-103.6 to the capital construction fund as ~~moneys become~~ MONEY  
19 BECOMES available in the general fund exempt account during the fiscal  
20 year beginning on July 1 of the fiscal year in which the transfer is made.  
21 Transfers between funds pursuant to this subsection (2.5) are not  
22 appropriations subject to the limitations of section 24-75-201.1. The  
23 amounts transferred pursuant to this subsection (2.5) are as follows:

24 (j) On July 1, 2015, five hundred thousand dollars; ~~and~~

25 (k) On July 1, 2016, five hundred thousand dollars; AND

26 (l) ON JULY 1, 2017, FIVE HUNDRED THOUSAND DOLLARS.

27 **SECTION 2.** In Colorado Revised Statutes, 24-75-302.5, **add**

1 (2.3) as follows:

2 **24-75-302.5. Controlled maintenance - trust fund - legislative**  
3 **declaration.** (2.3) FOR THE FISCAL YEAR COMMENCING JULY 1, 2017, THE  
4 STATE TREASURER SHALL TRANSFER TWENTY MILLION DOLLARS FROM THE  
5 GENERAL FUND TO THE CONTROLLED MAINTENANCE TRUST FUND.

6 **SECTION 3.** In Colorado Revised Statutes, 12-47.1-1201, **add**  
7 (9) as follows:

8 **12-47.1-1201. State historical fund - administration -**  
9 **legislative declaration - state museum cash fund - capitol dome**  
10 **restoration fund.** (9) FOR THE FISCAL YEAR COMMENCING JULY 1, 2017,  
11 THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE  
12 PRESERVATION GRANT PROGRAM ACCOUNT OF THE STATE HISTORICAL  
13 FUND ON OCTOBER 1, 2017, TO THE CAPITAL CONSTRUCTION FUND  
14 CREATED IN SECTION 24-75-302 TO RESTORE THE WINDOWS AND GRANITE  
15 EXTERIOR OF THE STATE CAPITOL BUILDING.

16 **SECTION 4. Safety clause.** The general assembly hereby finds,  
17 determines, and declares that this act is necessary for the immediate  
18 preservation of the public peace, health, and safety.
