After consideration on the merits, the Committee recommends the following:

HB17-1079 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 4, line 8, strike "manufacturing" and substitute
2 "~~manufacturing~~ MANUFACTURER".
- 3 Page 4, line 9, strike "register ~~such~~ THE facility with" and substitute
4 "~~register such facility with~~ SUBMIT AN APPLICATION TO".
- 5 Page 4, line 10, strike "manufacturing" and substitute "~~manufacturing~~
6 MANUFACTURER".
- 7 Page 4, strike line 15 substitute "~~the fee. Such~~ PAY AN ANNUAL
8 APPLICATION".
- 9 Page 4, line 17, strike "SECTION. THE registration" and substitute
10 "SECTION; EXCEPT THAT AN APPLICATION FEE IS NOT REQUIRED FOR A
11 NONPROFIT FACILITY. THE APPLICATION FOR registration".
- 12 Page 4, line 19, strike "if a registration is granted" and substitute "if a
13 ~~registration is granted~~ IF AN APPLICATION IS SUBMITTED", and strike "a
14 registration" and substitute "~~a registration~~ AN APPLICATION".
- 15 Page 4, line 20, strike "A" and substitute "AN APPLICATION".
- 16 Page 4, lines 21 and 22, strike "registration shall expire" and substitute

- 1 ~~"registration shall expire~~ APPLICATION EXPIRES".
2 Page 4, lines 22 and 23, strike "registration is granted." and substitute
3 ~~"registration is granted~~ APPLICATION IS SUBMITTED.".
- 4 Page 4, line 24, strike "ANNUAL" and substitute "IN ADDITION TO THE
5 APPLICATION FEE A FACILITY IS REQUIRED TO PAY PURSUANT TO
6 SUBSECTION (4)(a) OF THIS SECTION, THE SCHEDULE FOR ANNUAL".
- 7 Page 4, line 25, strike "MANUFACTURING" and substitute
8 "MANUFACTURERS".
- 9 Page 4, line 26, strike "ARE" and substitute "IS".
- 10 Page 5, lines 9 and 10, strike "ONE HUNDRED" and substitute "SIXTY".
- 11 Page 5, after line 10 insert:
12 "(II.5) A WHOLESALE FOOD MANUFACTURER OR STORAGE FACILITY
13 WITH GROSS ANNUAL SALES OF ONE HUNDRED THOUSAND DOLLARS OR
14 MORE BUT LESS THAN ONE HUNDRED FIFTY THOUSAND DOLLARS SHALL
15 PAY THE DEPARTMENT A REGISTRATION FEE OF TWO HUNDRED FIFTY
16 DOLLARS.".
- 17 Page 5, line 14, after "HUNDRED" insert "FIFTY".
- 18 Page 5, line 15, strike "TWO" and substitute "THREE".
- 19 Page 5, line 16, strike "FIFTY".
