Under existing law, Colorado state university - global campus is prohibited from admitting first-time freshman baccalaureate students who reside in Colorado and who are under 23 years of age. The bill removes that prohibition.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 23-31.3-101, **amend**

3 (1)(a) as follows:

4 **23-31.3-101. University established - role and mission.**

5 (1) (a) There is hereby established an online university to be known as
6 Colorado state university - global campus, referred to in this ~~article~~
7 ARTICLE 31.3 as "CSU global campus". CSU global campus is a
8 baccalaureate and graduate online university with the mission in Colorado
9 of offering baccalaureate degree programs for nontraditional students in
10 partnership with the Colorado community college system and selected
11 master-level graduate programs. For baccalaureate degree students
12 residing in Colorado, CSU global campus shall have moderately selective
13 admission standards. ~~CSU global campus shall not admit first-time~~
14 ~~freshman baccalaureate students who reside in Colorado and who are~~
15 ~~under twenty-three years of age.~~ CSU global campus shall comply with
16 all applicable statutes and rules.

17 **SECTION 2. Act subject to petition - effective date.** This act
18 takes effect at 12:01 a.m. on the day following the expiration of the
19 ninety-day period after final adjournment of the general assembly (August
20 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a
21 referendum petition is filed pursuant to section 1 (3) of article V of the
22 state constitution against this act or an item, section, or part of this act
23 within such period, then the act, item, section, or part will not take effect
24 unless approved by the people at the general election to be held in
25 November 2018 and, in such case, will take effect on the date of the
26 official declaration of the vote thereon by the governor.
