101 **CONCERNING DEPARTMENT OF PUBLIC SAFETY AUTHORITY TO REPEAL**
102 **RULES RELATING TO DEFUNCT BOARDS.**

Bill Summary

The victims compensation and assistance coordinating committee and the victims assistance and law enforcement advisory board in the department of public safety were repealed in 2009. The bill gives the executive director of the department of public safety the authority to repeal rules relating to those repealed boards.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 24-33.5-104.3
3 as follows:

4 **24-33.5-104.3. Executive director authority to repeal -**
5 **repeal.** (1) THE EXECUTIVE DIRECTOR MAY REPEAL RULES CONCERNING
6 THE VICTIMS ASSISTANCE AND LAW ENFORCEMENT ADVISORY BOARD,
7 STANDARDS FOR THE ADMINISTRATION OF CRIME VICTIM COMPENSATION
8 PROGRAMS, STANDARDS FOR THE ADMINISTRATION OF VICTIM ASSISTANCE
9 AND LAW ENFORCEMENT PROGRAMS, AND REVIEW OF VIOLATION OF THE
10 STANDARDS FOR THE ADMINISTRATION OF THE CRIME VICTIM
11 COMPENSATION AND VICTIM ASSISTANCE AND LAW ENFORCEMENT
12 PROGRAM AND RELATED SANCTIONS.

13 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2019.

14 **SECTION 2. Act subject to petition - effective date.** This act
15 takes effect at 12:01 a.m. on the day following the expiration of the
16 ninety-day period after final adjournment of the general assembly (August
17 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a
18 referendum petition is filed pursuant to section 1 (3) of article V of the
19 state constitution against this act or an item, section, or part of this act
20 within such period, then the act, item, section, or part will not take effect
21 unless approved by the people at the general election to be held in
22 November 2018 and, in such case, will take effect on the date of the
23 official declaration of the vote thereon by the governor.
