1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **amend** 2-2-1307 as  
3 follows:

4           **2-2-1307. Repeal of part.** This part 13 is repealed, effective July  
5 ~~1, 2018~~ SEPTEMBER 1, 2023. Prior to the repeal of this part 13, the council  
6 ~~shall~~ MUST be reviewed as provided for in section 2-3-1203.

7           **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
8 (6)(a)(V); and **add** (14)(a)(VI) as follows:

9           **2-3-1203. Sunset review of advisory committees - legislative**  
10 **declaration - definition - repeal.** (6) (a) The following statutory  
11 authorizations for the designated advisory committees will repeal on July  
12 1, 2018:

13           (V) ~~The Colorado youth advisory council created in section~~  
14 ~~2-2-1302.~~

15           (14)(a) The following statutory authorizations for the designated  
16 advisory committees are scheduled for repeal on September 1, 2023:

17           (VI) THE COLORADO YOUTH ADVISORY COUNCIL CREATED IN  
18 SECTION 2-2-1302.

19           **SECTION 3. Appropriation.** For the 2018-19 state fiscal year,  
20 \$25,000 is appropriated to the youth advisory council cash fund created  
21 in section 2-2-1306, C.R.S. This appropriation is from the general fund.  
22 The legislative department is responsible for the accounting related to this  
23 appropriation.

24           **SECTION 4. Effective date.** This act takes effect June 30, 2018.

25           **SECTION 5. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
