**A BILL FOR AN ACT**

101 **CONCERNING THE EXPANSION OF THE NUMBER OF DIRECTORS ON THE**  
102 **BOARD OF DIRECTORS OF THE STATE HISTORICAL SOCIETY.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The state historical society is currently governed by a board of directors with 9 members appointed by the governor. The bill expands the number of directors to 13. The governor is prohibited from appointing more than 7 members from the same major or minor political party.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-80-201.5, **amend**  
3 (1), (2)(a), (2)(b), and (2)(c); and **repeal** (4) as follows:

4 **24-80-201.5. State historical society - board - appointment -**  
5 **powers and duties.** (1) Effective ~~July 1, 2015~~ **OCTOBER 1, 2018**, the  
6 board of directors of the state historical society, referred to in this part 2  
7 as the "board" or "board of directors", consists of ~~nine~~ THIRTEEN members  
8 appointed pursuant to subsection (2) of this section.

9 (2) (a) The governor shall appoint, with the consent of the senate,  
10 ~~nine~~ THIRTEEN members of the board. If there is a vacancy of a member  
11 appointed pursuant to this subsection (2)(a), the governor shall appoint a  
12 new member of the board for the remainder of the unexpired term.

13 (b) Except as otherwise provided in this subsection (2)(b),  
14 members of the board serve three-year terms. ~~The members first~~  
15 ~~appointed to the board take office on July 1, 2015.~~ Of the appointments  
16 of members to ~~take office on July 1, 2015~~ **FILL THE FOUR NEW POSITIONS**  
17 **CREATED ON OCTOBER 1, 2018**, the governor shall designate:

18 (I) ~~Three members~~ **ONE MEMBER** of the board to have ~~terms A~~  
19 ~~TERM~~ expiring on ~~July 1, 2016~~ **JULY 1, 2019**;

20 (II) ~~Three members~~ **ONE MEMBER** of the board to have ~~terms A~~  
21 ~~TERM~~ expiring on ~~July 1, 2017~~ **JULY 1, 2020**; and

22 (III) ~~Three~~ **TWO** members of the board to have terms expiring on  
23 ~~July 1, 2018~~ **JULY 1, 2021**. Thereafter, the terms of the members of the  
24 board are three years.

25 (c) In appointing the ~~nine~~ THIRTEEN members of the board, the  
26 governor shall ensure that collectively the members possess the skills in  
27 state financial, legal, and regulatory expertise as required to oversee the

1 state historical society and shall consider both geographic and cultural  
2 diversity of the ~~nine~~ THIRTEEN members. The governor shall appoint no  
3 more than five members from the same political party NO MORE THAN  
4 SEVEN MEMBERS APPOINTED BY THE GOVERNOR SHALL BE AFFILIATED  
5 WITH ONE POLITICAL PARTY OR UNAFFILIATED PERSONS.

6 (4) ~~Policies, procedures, bylaws, resolutions, and agreements~~  
7 ~~approved by the board prior to July 1, 2015, remain in full force and~~  
8 ~~effect unless and until changed by the board taking office July 1, 2015.~~

9 **SECTION 2. Act subject to petition - effective date.** This act  
10 takes effect October 1, 2018; except that, if a referendum petition is filed  
11 pursuant to section 1 (3) of article V of the state constitution against this  
12 act or an item, section, or part of this act within the ninety-day period  
13 after final adjournment of the general assembly, then the act, item,  
14 section, or part will not take effect unless approved by the people at the  
15 general election to be held in November 2018 and, in such case, will take  
16 effect on the date of the official declaration of the vote thereon by the  
17 governor.
