A BILL FOR AN ACT

101 CONCERNING AN EXCEPTION FROM THE MANDATORY REPORTING
102 REQUIREMENTS FOR PERSONS PROVIDING LEGAL ASSISTANCE TO
103 AREA AGENCIES ON AGING.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, staff, and staff of contracted providers, of area agencies on aging are mandatory reporters of the mistreatment of an at-risk elder or an at-risk adult with an intellectual and developmental disability. The bill creates a mandatory reporter exception for providers of legal assistance and their staff.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 18-6.5-108, **amend**
3 (1)(b)(XVII) as follows:

4 **18-6.5-108. Mandatory reports of mistreatment of at-risk**
5 **elders and at-risk adults with IDD - list of reporters - penalties.**

6 (1) (b) The following persons, whether paid or unpaid, shall report as
7 required by subsection (1)(a) of this section:

8 (XVII) Staff, and staff of contracted providers, of area agencies
9 on aging, except PROVIDERS OF LEGAL ASSISTANCE AND ASSOCIATED
10 STAFF AND the long-term care ombudsmen;

11 **SECTION 2. Act subject to petition - effective date.** This act
12 takes effect September 1, 2018; except that, if a referendum petition is
13 filed pursuant to section 1 (3) of article V of the state constitution against
14 this act or an item, section, or part of this act within the ninety-day period
15 after final adjournment of the general assembly, then the act, item,
16 section, or part will not take effect unless approved by the people at the
17 general election to be held in November 2018 and, in such case, will take
18 effect on the date of the official declaration of the vote thereon by the
19 governor.
