**Bill Summary**

**Statutory Revision Committee.** The bill clarifies that members of the radiation advisory committee are reimbursed for necessary and actual expenses incurred in attendance at meetings or for authorized business of the committee.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1. Legislative declaration.** The general assembly  
3 declares that the purpose of this act is to correct defects in the law. The  
4 general assembly further declares that clarifying these statutory provisions  
5 does not alter the scope or applicability of the remaining statutes.

6           **SECTION 2.** In Colorado Revised Statutes, 25-11-105, **amend**  
7 (1) as follows:

8           **25-11-105. Radiation advisory committee.** (1) The governor  
9 shall appoint a radiation advisory committee of nine members, no more  
10 than four of whom ~~shall~~ represent any one political party and three of  
11 whom ~~shall~~ represent industry, three the healing arts, and three the public  
12 and private institutions of higher education. Members of the committee  
13 ~~shall~~ serve at the discretion of the governor and ~~shall be~~ ARE reimbursed  
14 for necessary and actual expenses incurred in attendance at meetings or  
15 for authorized business of the ~~board~~ COMMITTEE. The committee shall  
16 furnish to the department such technical advice as may be desirable or  
17 required on matters relating to the radiation control program.

18           **SECTION 3. Act subject to petition - effective date.** This act  
19 takes effect at 12:01 a.m. on the day following the expiration of the  
20 ninety-day period after final adjournment of the general assembly (August  
21 2, 2019, if adjournment sine die is on May 3, 2019); except that, if a  
22 referendum petition is filed pursuant to section 1 (3) of article V of the  
23 state constitution against this act or an item, section, or part of this act  
24 within such period, then the act, item, section, or part will not take effect  
25 unless approved by the people at the general election to be held in

- 1 November 2020 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
