101      **CONCERNING THE REPEAL OF THE TRANSFER OF UNEXPENDED MONEY**  
102              **FOR REIMBURSING COUNTIES FOR EXEMPTIONS FROM PROPERTY**

**Bill Summary**

**Joint Budget Committee.** The bill repeals the current provision that directs the state treasurer to transfer the unexpended money from the appropriation to pay counties for the amount of money lost due to exemptions from property taxes to the senior services account (account) of the older Coloradans cash fund (fund) and to the veterans assistance

grant program cash fund. The bill directs the state treasurer to transfer any money remaining in the account to the fund and repeals the account. The bill directs the state treasurer to deduct \$13 million from the fund and transfer it to the general fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 39-3-207, **repeal** (6)  
3 as follows:

4 **39-3-207. Reporting of exemptions - reimbursement to local**  
5 **governmental entities.** (6) ~~On June 30, 2016, and on each June 30~~  
6 ~~thereafter, of the amount by which the total estimated amount specified~~

16 **SECTION 2.** In Colorado Revised Statutes, 26-11-205.5, **amend**  
17 (5)(b); and **add** (5)(c) as follows:

19 **- cash fund - repeal.** (5) (b) (I) There is hereby created within the fund  
20 the senior services account, referred to in this ~~paragraph (b)~~ **SUBSECTION**

7 (III) THIS SUBSECTION (5)(b) IS REPEALED, EFFECTIVE JULY 1,  
8 2020.

9 (c) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION (5) TO  
10 THE CONTRARY, ON JULY 1, 2020, THE STATE TREASURER SHALL DEDUCT  
11 THIRTEEN MILLION DOLLARS FROM THE FUND AND TRANSFER SUCH SUM TO  
12 THE GENERAL FUND.

13 **SECTION 3. Safety clause.** The general assembly hereby finds,  
14 determines, and declares that this act is necessary for the immediate  
15 preservation of the public peace, health, or safety.
