102                    **UNIFORM COMMERCIAL CODE FILING FEES TO PROVIDE FUNDING**  
103                    **FOR THE COLORADO FRAUD INVESTIGATORS UNIT.**

**Bill Summary**

The secretary of state currently charges uniform commercial code filing fees. Of each filing fee, \$4 is transferred for deposit in the Colorado identity theft and financial fraud cash fund to support activities of the Colorado fraud investigators unit. The fee is set to repeal in 2020. The bill extends the scheduled repeal date for the fee and for an associated report

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1704,  
3 **amend** (7) as follows:

4           **24-33.5-1704. Colorado fraud investigators unit - creation -**  
5 **duties - repeal.** (7) (a) Beginning in 2014, and every year thereafter  
6 through ~~2020~~ 2024, the department of public safety shall report on the  
7 activities of the unit as part of its "State Measurement for Accountable,  
8 Responsive, and Transparent (SMART) Government Act" hearing  
9 required by section 2-7-203.

10           (b) This subsection (7) is repealed, effective ~~July 1, 2021~~ JULY 1,  
11 2025.

12           **SECTION 2.** In Colorado Revised Statutes, 24-33.5-1707,  
13 **amend** (2)(a)(I)(B) as follows:

14           **24-33.5-1707. Funding - cash fund created - donations - repeal.**  
15 (2) (a) (I) (B) Notwithstanding subsection (2)(a)(I)(A) of this section,  
16 from July 1, 2014, through ~~June 30, 2020~~ JUNE 30, 2024, the surcharge is  
17 four dollars. This subsection (2)(a)(I)(B) is repealed, effective ~~July 1,~~  
18 ~~2021~~ JULY 1, 2025.

19           **SECTION 3. Safety clause.** The general assembly hereby finds,  
20 determines, and declares that this act is necessary for the immediate  
21 preservation of the public peace, health, or safety.
